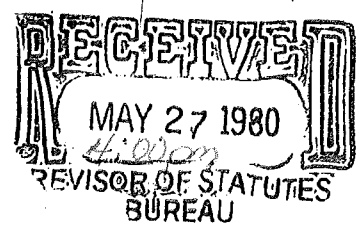

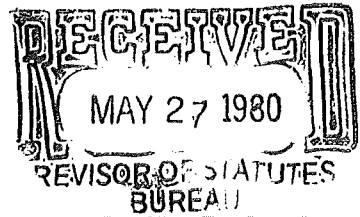

IN THE MATTER OF RULEMAKING : ORDER OF THE PSYCHOLOGY
PROCEEDINGS BEFORE THE : EXAMINING BOARD REPEALING,
PSYCHOLOGY EXAMINING BOARD : AMENDING OR ADOPTING RULES

Relating to rules concerning requirements for licensure.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

The amendment to Psy 1.03(4)(a) is proposed to enable persons certified at the highest level by the Department of Public Instruction as school psychologists to act as supervisors for applicants for licensure who are meeting the 1500-hour psychological work experience requirement in the professional practice of psychology as specified in s. 455.04(1)(d), Stats.

Sections Psy 1.05(3) and (4) and being renumbered Psy 1.05(4) and (5) respectively.

Section Psy 1.05(3) is being created to define equivalent requirements which must be met by persons not having a doctoral degree in psychology who are applying for a psychologist license under s. 455.04(1), Stats.

In amending section Psy 1.03(4)(a) and creating section Psy 1.05(3), the board is meeting objections raised by the Joint Committee for Review of Administrative Rules relating to current provisions in the code in these areas.

ORDER

Now therefore it is ordered that pursuant to authority vested in the Psychology Examining Board in ss. 15.08(5), 227.014 and 455.08, Stats., the Psychology Examining Board hereby amends and adopts rules interpreting s. 455.04(1), Stats., as follows:

1. Section Psy 1.03(4)(a) of the Wisconsin administrative code is amended to read:

(a) For every 6 hours of direct client/patient contact, one hour of professional supervision provided by a practicing psychologist who is licensed for independent practice in settings where licensure is required, by a school psychologist certified at the highest level by the Department of Public Instruction within school psychology settings, or by a license-eligible psychologist in settings where licensure is not required.

2. Sections Psy 1.05(3) and (4) of the Wisconsin administrative code are renumbered Psy 1.05(4) and (5) respectively.

3. Section Psy 1.05(3) of the Wisconsin administrative code is created to read:

(3) Applicant must meet the following requirements. (a) Possess a masters degree in psychology from an organized program designed to train the student for the practice of psychology, granted by an accredited university as defined in s. 455.04(1)(c). Determination of whether the masters degree is "in psychology" shall be made on the basis of criteria specified in Psy 1.04(1) and (2).


(b) The applicant's graduate transcripts must indicate completion of at least 57 graduate semester hours in psychology exclusive of thesis credit. Of the 57 graduate semester hours, 36 graduate semester hours shall be in the basic courses distributed among the following basic areas: abnormal, comparative, developmental, experimental, history and systems, individual differences, learning theory, motivation, personality theory, perception, physiological psychology, social psychology and statistical and research methods. No more than 12 graduate semester hours may be credited to any of the areas. The remaining 21 graduate semester hours shall be in applied areas including: (1) psycho-diagnosis, personality and behavior assessment, (2) psychotherapy, counseling, behavior modification techniques, and other intervention strategies, (3) interviewing, (4) administering and interpreting tests of mental abilities, aptitudes, interest, attitudes, personality, emotions, and motivation, (5) assessing public opinion, and (6) industrial and organizational psychology.

(c) The applicant must have completed three years (4,500 hours) experience in an organized psychological services delivery system. The 4,500 hours must be gained within a period of no more than five consecutive years. This experience shall be directed to developing the skills of a professional psychologist, appropriate to the area(s) of intended practice. The quality shall be validated by a psychologist who meets the qualifications of supervisors noted in Psy 1.03(4)(a). This experience is in addition to, and must be gained subsequent to, the year of experience specified in Psy 1.03.

(d) When the requirements specified in (a) through (c) have been met, the applicant will be admitted to, and must pass, the Professional Examination Service Examination for the Professional Practice of Psychology.

The rules contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026(1), Stats.
