**SENATE AMENDMENT 12,  
TO SENATE SUBSTITUTE AMENDMENT 2,  
TO SENATE BILL 70**

June 28, 2023 - Offered by Senators AGARD, CARPENTER, HESSELBEIN, L. JOHNSON,  
LARSON, PFAFF, ROYS, SMITH, SPREITZER, TAYLOR and WIRCH.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 374, line 11: after that line insert:

3 “**SECTION 1.** 20.455 (2) (a) of the statutes is amended to read:

4 20.455 (2) (a) *General program operations.* The amounts in the schedule for  
5 general program operations, including operating the state crime laboratories,  
6 performing criminal investigations, providing law enforcement services and,  
7 providing independent crime laboratory services for defendants in a felony case upon  
8 authorization by the presiding judge, and operating the office of school safety.

9 **SECTION 9227. Fiscal changes; Justice.**

10 (1e) OFFICE OF SCHOOL SAFETY. In the schedule under s. 20.005 (3) for the  
11 appropriation to the department of justice under s. 20.455 (2) (a), the dollar amount  
12 for fiscal year 2023-24 is increased by \$387,800 to increase the authorized FTE

1 positions for the department by 6.0 GPR positions for the operations of the office of  
2 school safety to support and enhance school safety initiatives. In the schedule under  
3 s. 20.005 (3) for the appropriation to the department of justice under s. 20.455 (2) (a),  
4 the dollar amount for fiscal year 2024-25 is increased by \$608,300 to provide funding  
5 for the positions authorized under this subsection and to increase the authorized  
6 FTE positions by 1.2 additional GPR positions for the same purpose.

7 (2e) FLEXIBLE FULLTIME EQUIVALENT POSITIONS. In the schedule under s. 20.005  
8 (3) for the appropriation to the department of justice under s. 20.455 (1) (a), the dollar  
9 amount for fiscal year 2023-24 is increased by \$601,000 to increase the authorized  
10 FTE positions for the department by 7.0 GPR positions for flexible fulltime  
11 equivalent positions within the department to be used at the attorney general's  
12 discretion. In the schedule under s. 20.005 (3) for the appropriation to the  
13 department of justice under s. 20.455 (1) (a), the dollar amount for fiscal year  
14 2024-25 is increased by \$601,000 to provide funding for the positions authorized  
15 under this subsection.”.
