WHEREAS, Title I, Part B, Sec. 203(a) of Public Law 90-351 as amended (Omnibus Crime Centrel and Safe Streets Act of 1968) has empowered the Governor to establish and maintain a State Criminal Justice Planning Agency; and

MHEREAS, in accordance with Title I, Part B, Sec. 203(a) of the Act, the State Criminal Justice Planning Agency shall be subject to the jurisdiction of the Governor; and

WHEREAS, in accordance with Title I, Part B, Sec. 203(c) of the Act, the State Criminal Justice Planning Agency shall make such arrangements as such agency doesn necessary to provide that at least 40 per centum of all Pederal funds granted to such agency under this part for any fiscal year will be available to units of general local government or combinations of such units to enable such units and combinations of such units to enable such units and combinations of such units to participate in the formulation of the comprehensive State Criminal Justice Improvement Plan required under this part; and

WHEREAS, the Wisconsin Council on Criminal Justice has recommended the creation of ten (10) criminal justice planning regions as hereinafter enumerated; and

WHEREAS, the Wisconsin Council on Criminal Justice has recommended the creation of the position of regional director in each of the regions and that said director be designated as a state employee pursuant to Chapter 16.00 of the Wisconsin Statutes, 1969; and

MHMMAS, said regional directors shall be appointed in accordance with the organization and policy statement hereinafter attached; and

WHEREAS, said regions shall each have an advisory board composed of not less than thirteen (13) nor more than nineteen (19) members, the selection of which shall be made by the Executive Director of the Wisconsin Council on Criminal Justice with the final approval vested in the Governor; the structure of which shall be in accordance with the organization and policy statement hereinafter attached; and

WHEREAS, the Wisconsin Council on Criminal Justice has further recommended that the region bounded by Milwaukee County is in and of itself a criminal justice planning region of special character; the structure of which shall be in accordance with the organization and policy statement hereinafter attached.

NOW, THEREFORE, I, PATRICK J. LUCLY, Governor of the State of Wisconsin, do hereby establish the recommended Criminal Justice Planning Regions and specified position of regional director within the personnel structure of the State Criminal Justice Planning Agency as follows:

## Section I

The State of Wisconsin shall be divided into ten (10) criminal justice planning regions. The ten regions shall be numbered as hereinafter provided and the counties under each region designated shall comprise said region.

- a) Region One Northwest Douglas, Bayfield, Ashland, Iron,
  Burnette, Washburn, Sawyer, Price,
  Rusk, Taylor
- b) Region Two Northeast Vilas, Oneida, Lincoln, Forest, Florence, Langlade, Oconto, Marinette, Menominee, Shawano
- c) Region Three Upper West Central Polk, Barron, St. Croix, Pierce,
  Dunn, Pepin, Eau Claire, Chippewa,
  Clark
- d) Region Four Lower West Central Buffalo, Trempealeau, Jackson,
  LaCrosse, Monroe, Vernon, Crawford
- e) Region Five Central Marathon, Wood, Portage, Juneau, Adams, Waushara, Marquette, Green Lake
- f) Region Six East Central Waupaca, Outagamie, Winnebago,
  Fond du Lac, Sheboygan, Manitowoc,
  Calumet, Brown, Kewaunee, Door
- g) Region Seven Southwest Grant, Iowa, LaFayette, Green, Richland
- h) Region Eight South Central Sauk, Columbia, Dedge, Dane,
  Jefferson, Rock
- i) Region Nine Southeast Ozaukee, Washington, Waukesha, Walworth, Racine, Kenosha
- j) Region Ten Metropolitan Milwaukee City of Milwaukee, Milwaukee County,
  Suburban Municipalities of Milwaukee
  County

# Section II

Each of the criminal justice planning regions will have as its chief executive a regional director. With the exception of Region Ten, said director shall be an unclassified state employee and be subject to appropriate rules and regulations as promulgated by the

State Bureau of Personnel of the State Department of Administration and by the State Criminal Justice Planning Agency.

## Section III

The regional director will be appointed in accordance with the organization and policy statement horeinafter attached.

## Section IV

Regional Advisory Boards will be created in each region with thirteen to mineteen members in accordance with the organization and policy statement hereinafter attached.

## Section V

Milwaukee County will be designated a criminal justice planning region of special character and structured in accordance with the organization and policy statement hereinafter attached.
