



EXECUTIVE ORDER #10

WHEREAS, the well-being of Wisconsin's citizens is directly related to the quality of their physical fitness and health; and

WHEREAS, it is in the best interest of Wisconsin's citizens to have a state council coordinating programs and education concerning physical fitness and health for the entire state; and

WHEREAS, the development of a partnership between business and government would be useful in accomplishing the goal of promotion of better health and physical fitness; and

WHEREAS, a state council would be helpful to the Governor in identifying the fitness needs of the citizenry, and in promoting better health and physical fitness through existing programs and new programs;

NOW, THEREFORE, I, ANTHONY S. EARL, Governor of the State of Wisconsin, pursuant to the authority vested in me by Section 14.019 of the Wisconsin Statutes, do hereby:

1. Establish the Governor's Council on Physical Fitness and Health for the State of Wisconsin;
2. Provide that the Council shall be comprised of fifteen (15) members appointed by the Governor to serve at his pleasure;
3. Provide that the Governor shall designate a Chairperson from the membership of the Council;
4. Provide that the Council shall undertake the following tasks:
 - a) to forge cooperative relationships between state agencies, educational institutions, businesses, associations and foundations to improve the availability of fitness and health activities to all citizens in Wisconsin;
 - b) to implement educational programs that will increase interest and participation in health and fitness programs;

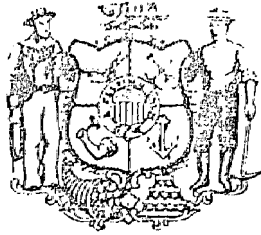

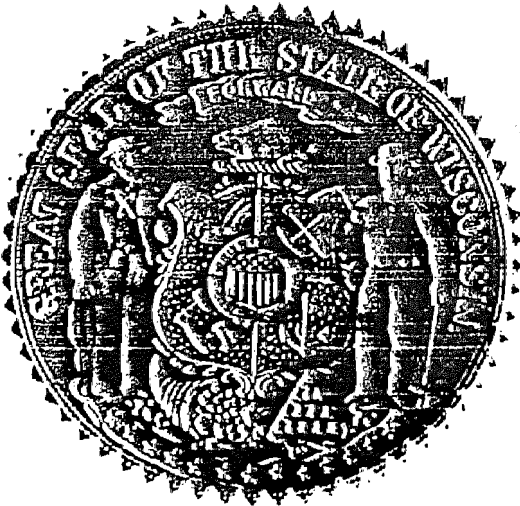

 - c) to seek necessary resources to support the Council and its programs;

5. Provide that the Council shall make recommendations to the Governor concerning program and policy development relating to fitness and better health;
6. Provide that the Department of Health and Social Services, Division of Health shall give staff support to the Council to accomplish these tasks; and
7. Instruct the Secretary of the Department of Administration to accept under section 20.505(3)(g) all moneys received from gifts, grants, bequests, and devises given to the Governor's Council on Physical Fitness and Health to carry out the purposes for which made.
