



1995 SENATE BILL 316

August 30, 1995 - Introduced by Senators ANDREA, WINEKE, MOEN, DECKER and CLAUSING, cosponsored by Representatives WIRCH, KREUSER, GRONEMUS, BLACK, CULLEN, GROBSCHMIDT, NOTESTEIN, BALDUS, PLOMBON, RYBA, BOYLE and BALDWIN. Referred to Committee on State Government Operations and Corrections.

1 **AN ACT to amend** 15.16 (1) (intro.), 15.16 (1) (a) (intro.), 15.16 (1) (a) 1. and 40.03
2 (7) (a) of the statutes; **relating to:** public school teacher representation on the
3 employe trust funds board and increasing the size of the employe trust funds
4 board.

Analysis by the Legislative Reference Bureau

Under current law, the employe trust funds board is responsible for the direction and supervision of the department of employe trust funds. The employe trust funds board consists of 12 members, one of whom is required to be a public school teacher who participates in the Wisconsin retirement system and serves on the teachers retirement board. This bill increases the size of the employe trust funds board to 14 members and requires that 3 of its members be such public school teachers.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 **SECTION 1.** 15.16 (1) (intro.) of the statutes is amended to read:
6 15.16 (1) EMPLOYE TRUST FUNDS BOARD. (intro.) The employe trust funds board
7 shall consist of ~~12 members.~~ The board shall consist of the governor or the governor's
8 designee on the group insurance board, the secretary of employment relations or the

1 secretary's designee and ~~10~~ the following persons appointed for 4-year terms as
2 follows:

3 **SECTION 2.** 15.16 (1) (a) (intro.) of the statutes is amended to read:

4 15.16 (1) (a) (intro.) ~~Four~~ Six members shall be members of the teachers
5 retirement board, appointed by that board.

6 **SECTION 3.** 15.16 (1) (a) 1. of the statutes is amended to read:

7 15.16 (1) (a) 1. At least ~~one appointee~~ 3 appointees under this paragraph shall
8 have been appointed or elected to the board under s. 15.165 (3) (a) 1. or 2.

9 **SECTION 4.** 40.03 (7) (a) of the statutes is amended to read:

10 40.03 (7) (a) Shall appoint ~~4~~ 6 members of the employe trust funds board as
11 provided under s. 15.16 (1).

12 **SECTION 5. Nonstatutory provisions.**

13 (1) Notwithstanding the length of terms specified under section 15.16 (1)
14 (intro.) of the statutes, one additional member of the employe trust funds board,
15 whose position is created by this act, shall be initially appointed for a term expiring
16 on May 1, 1997, and one additional member of the employe trust funds board, whose
17 position is created by this act, shall be initially appointed for a term expiring on May
18 1, 1999.
