## 2011 ASSEMBLY RESOLUTION 24

March 13, 2012 - Introduced by COMMITTEE ON RULES.

1 **Relating to:** establishing special orders of business for Wednesday, March 14, 2012.

2 ***Resolved by the assembly, That:***

**SECTION 1. Special order scheduled.** The following proposals shall be special orders of business on Wednesday, March 14, 2012, at the times shown:

- (1) At 9:01 a.m., 2011 Assembly Bill 144, relating to: creating a commission on financial aid consolidation and modernization.
- (2) At 9:02 a.m., 2011 Assembly Bill 209, relating to: mandatory minimum sentences for certain child sex offenses.
- (3) At 9:03 a.m., 2011 Assembly Bill 232, relating to: rights of crime victims and witnesses.
- (4) At 9:04 a.m., 2011 Assembly Bill 311, relating to: creating a sporting recruitment and retention council, programs to encourage recruitment of hunters and trappers, restrictions on expenditures under the Warren Knowles-Gaylord Nelson stewardship program, reduced fees for certain first-time hunting and trapping approvals, high school credit under and administration of the hunter and trapper education programs, waiving fishing license requirements for a weekend ice fishing event, and sturgeon spearing license age requirements.
