



2021 ASSEMBLY BILL 390

June 8, 2021 - Introduced by Representatives NOVAK, KURTZ and TRANEL. Referred to Committee on State Affairs.

1 **AN ACT relating to:** grants for the Memorial Hospital of Lafayette County,
2 emergency medical services, and the city of Reedsburg community center.

Analysis by the Legislative Reference Bureau

This bill directs the governor to award several grants from moneys the governor accepts from the federal government pursuant to the federal American Rescue Plan Act of 2021. First, the bill directs the governor to award a \$4,000,000 grant to the Memorial Hospital of Lafayette County for facility planning, expansion, and construction. Second, the bill directs the governor to award \$5,500,000 in grants in fiscal year 2021-22 and another \$5,500,000 in grants in fiscal year 2022-23 to support emergency medical services. Finally, the bill directs the governor to award \$400,000 in grants for improvements to the city of Reedsburg community center.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 **SECTION 1. Nonstatutory provisions.**

4 (1) MEMORIAL HOSPITAL OF LAFAYETTE COUNTY. Of the moneys the governor

1 Rescue Plan Act of 2021, P.L. 117-2, the governor shall award a \$4,000,000 grant to

3 expansion, and construction.

4 (2) EMERGENCY MEDICAL SERVICES. Of the moneys the governor accepts from the
5 federal government under s. 16.54 pursuant to the federal American Rescue Plan Act
6 of 2021, P.L. 117-2, the governor shall award \$5,500,000 in grants in fiscal year
7 2021-22 to support emergency medical services under s. 256.12 (4) and (5). Of the
8 moneys the governor accepts from the federal government under s. 16.54 pursuant
9 to the federal American Rescue Plan Act of 2021, P.L. 117-2, the governor shall
10 award \$5,500,000 in grants in fiscal year 2022-23 to support emergency medical
11 services under s. 256.12 (4) and (5).

12 (3) GRANTS FOR THE REEDSBURG COMMUNITY CENTER. Of the moneys the governor
13 accepts from the federal government under s. 16.54 pursuant to the federal American
14 Rescue Plan Act of 2021, P.L. 117-2, the governor shall award \$400,000 in grants for
15 improvements to the city of Reedsburg community center.
