Analysis by the Legislative Reference Bureau

This bill ratifies and enters Wisconsin into the Psychology Interjurisdictional Compact (compact), which provides for the ability of a psychologist to practice more easily in other compact states. Significant provisions of the compact include:

1. The creation of a Psychology Interjurisdictional Compact Commission (commission), which includes one member or representative of the licensure boards of each member state. The commission has various powers and duties granted in the compact, including overseeing the administration of the compact, enforcing the compact, adopting bylaws, promulgating binding rules for the compact, employing officers and employees, and establishing and electing an executive board. The commission may levy on and collect an annual assessment from each member state or impose fees on other parties to cover the cost of the operations and activities of the commission and its staff.

2. The ability for a psychologist to obtain authority to practice interjurisdictional telepsychology in another compact state if the psychologist satisfies certain criteria. “Telepsychology” is defined as the provision of psychological services using telecommunication technologies. The compact specifies that a home state, defined as the state where the psychologist is physically located, maintains authority over the license of any psychologist practicing into a receiving state, defined as the compact state where the client or patient is physically located, under the authority to practice interjurisdictional telepsychology. The compact provides that a home state’s license authorizes a psychologist to practice in a receiving state under the authority to practice interjurisdictional telepsychology if the compact state satisfies certain requirements, including requiring the psychologist to hold an active E.Passport, defined as a certificate issued by the Association of State and Provincial Psychology Boards (ASPPB) that promotes the standardization in the criteria of interjurisdictional telepsychology practice and facilitates the process for licensed psychologists to provide telepsychological services across state lines. A psychologist practicing into a receiving state under the authority to practice interjurisdictional telepsychology is subject to the receiving state’s scope of practice. The compact further provides that a psychologist may practice in a receiving state under the authority to practice interjurisdictional telepsychology only in the performance of the scope of practice for psychology as assigned by an appropriate state psychology regulatory authority and under circumstances specified in the compact. A receiving state may limit or revoke a psychologist’s authority to practice interjurisdictional telepsychology in the receiving state and may take any other necessary actions to protect the health and safety of the receiving state’s citizens. If a psychologist’s license or authority to practice interjurisdictional telepsychology is restricted, suspended, or otherwise limited, the psychologist’s

E.Passport is revoked and the psychologist may not practice telepsychology in a compact state under the authority to practice interjurisdictional telepsychology.

3. The ability for a psychologist to obtain temporary authorization for the psychologist to provide temporary in-person, face-to-face psychological services in another compact state for up to 30 days within a calendar year if the psychologist satisfies certain criteria. The compact provides that a home state's license grants temporary authorization to practice to a psychologist in a distant state if the compact state satisfies certain requirements, including requiring the psychologist to hold an active interjurisdictional practice certificate (IPC), defined as a certificate issued by the ASPPB that grants temporary authority to practice based on notification to the state psychology regulatory authority of intention to practice temporarily, and verification of one's qualifications for such practice. A psychologist practicing into a distant state, defined as the state where the psychologist is physically present to provide temporary in-person, face-to-face psychological services, under the temporary authorization to practice is subject to the distant state's scope of practice. A psychologist practicing into a distant state under the temporary authorization to practice is subject to the distant state's authority and law. A distant state may limit or revoke a psychologist's temporary authorization to practice in the distant state and may take any other necessary actions to protect the health and safety of the receiving state's citizens. If a psychologist's license or temporary authorization to practice is restricted, suspended, or otherwise limited, the psychologist's IPC is revoked and the psychologist may not practice under the temporary authorization to practice.

4. The ability of member states to issue subpoenas that are enforceable in other states.

5. The creation of a coordinated database and reporting system containing licensure and disciplinary action information on psychologists to whom the compact is applicable. The compact requires all home state disciplinary orders that impose adverse actions to be reported to the commission. A member state must submit a uniform data set to the data system on all individuals to whom this compact is applicable as required by the rules of the commission.

6. Provisions regarding resolutions of disputes between the commission and member states and between member and nonmember states, including a process for termination of a state's membership in the compact if the state defaults on its obligations under the compact.

Since the compact has already been enacted by the minimum number of states required for it to become active, the compact becomes effective in this state upon enactment of the bill. The compact provides that it may be amended upon enactment of an amendment by all member states. A state may withdraw from the compact by repealing the statute authorizing the compact, but the compact provides that a withdrawal does not take effect until six months after the effective date of that repeal.

16 alternative programs to not provide telepsychology services under the authority to
17 practice interjurisdictional telepsychology or provide temporary psychological
18 services under the temporary authorization to practice in any other compact state
19 during the term of the alternative program.

20 (g) No other judicial or administrative remedies shall be available to a
21 psychologist in the event a compact state imposes an adverse action pursuant to par.

22 (c).

23 **(8) ARTICLE VIII — ADDITIONAL AUTHORITIES INVESTED IN A COMPACT STATE'S**
24 **PSYCHOLOGY REGULATORY AUTHORITY.** In addition to any other powers granted under

1 state law, a compact state's psychology regulatory authority shall have the authority
2 under this compact to:

3 (a) Issue subpoenas, for both hearings and investigations, which require the
4 attendance and testimony of witnesses and the production of evidence. Subpoenas
5 issued by a compact state's psychology regulatory authority for the attendance and
6 testimony of witnesses, and/or the production of evidence from another compact state
7 shall be enforced in the latter state by any court of competent jurisdiction, according
8 to that court's practice and procedure in considering subpoenas issued in its own
9 proceedings. The issuing state psychology regulatory authority shall pay any
10 witness fees, travel expenses, mileage and other fees required by the service statutes
11 of the state where the witnesses and/or evidence are located; and

12 (b) Issue cease and desist and/or injunctive relief orders to revoke a
13 psychologist's authority to practice interjurisdictional telepsychology and/or
14 temporary authorization to practice.

15 (c) During the course of any investigation, a psychologist may not change
16 his/her home state licensure. A home state psychology regulatory authority is
17 authorized to complete any pending investigations of a psychologist and to take any
18 actions appropriate under its law. The home state psychology regulatory authority
19 shall promptly report the conclusions of such investigations to the commission. Once
20 an investigation has been completed, and pending the outcome of said investigation,
21 the psychologist may change his/her home state licensure. The commission shall
22 promptly notify the new home state of any such decisions as provided in the rules of
23 the commission. All information provided to the commission or distributed by
24 compact states pursuant to the psychologist shall be confidential, filed under seal
25 and used for investigatory or disciplinary matters. The commission may create

1 additional rules for mandated or discretionary sharing of information by compact
2 states.

3 **(9) ARTICLE IX — COORDINATED LICENSURE INFORMATION SYSTEM.** (a) The
4 commission shall provide for the development and maintenance of a coordinated
5 licensure information system (coordinated database) and reporting system
6 containing licensure and disciplinary action information on all psychologists
7 individuals to whom this compact is applicable in all compact states as defined by the
8 rules of the commission.

9 (b) Notwithstanding any other provision of state law to the contrary, a compact
10 state shall submit a uniform data set to the coordinated database on all licensees as
11 required by the rules of the commission, including:

- 12 1. Identifying information;
- 13 2. Licensure data;
- 14 3. Significant investigatory information;
- 15 4. Adverse actions against a psychologist's license;
- 16 5. An indicator that a psychologist's authority to practice interjurisdictional
17 telepsychology and/or temporary authorization to practice is revoked;
- 18 6. Non-confidential information related to alternative program participation
19 information;
- 20 7. Any denial of application for licensure, and the reasons for such denial; and
- 21 8. Other information which may facilitate the administration of this compact,
22 as determined by the rules of the commission.

23 (c) The coordinated database administrator shall promptly notify all compact
24 states of any adverse action taken against, or significant investigative information
25 on, any licensee in a compact state.

1 (d) Compact states reporting information to the coordinated database may
2 designate information that may not be shared with the public without the express
3 permission of the compact state reporting the information.

4 (e) Any information submitted to the coordinated database that is
5 subsequently required to be expunged by the law of the compact state reporting the
6 information shall be removed from the coordinated database.

7 **(10) ARTICLE X — ESTABLISHMENT OF THE PSYCHOLOGY INTERJURISDICTIONAL**
8 **COMPACT COMMISSION.** (a) The compact states hereby create and establish a joint
9 public agency known as the Psychology Interjurisdictional Compact Commission.

10 1. The commission is a body politic and an instrumentality of the compact
11 states.

12 2. Venue is proper and judicial proceedings by or against the commission shall
13 be brought solely and exclusively in a court of competent jurisdiction where the
14 principal office of the commission is located. The commission may waive venue and
15 jurisdictional defenses to the extent it adopts or consents to participate in alternative
16 dispute resolution proceedings.

17 3. Nothing in this compact shall be construed to be a waiver of sovereign
18 immunity.

19 (b) *Membership, voting, and meetings.* 1. The commission shall consist of one
20 voting representative appointed by each compact state who shall serve as that state's
21 commissioner. The state psychology regulatory authority shall appoint its delegate.
22 This delegate shall be empowered to act on behalf of the compact state. This delegate
23 shall be limited to:

24 a. Executive director, executive secretary or similar executive;

1 b. Current member of the state psychology regulatory authority of a compact
2 state; OR

3 c. Designee empowered with the appropriate delegate authority to act on behalf
4 of the compact state.

5 2. Any commissioner may be removed or suspended from office as provided by
6 the law of the state from which the commissioner is appointed. Any vacancy
7 occurring in the commission shall be filled in accordance with the laws of the compact
8 state in which the vacancy exists.

9 3. Each commissioner shall be entitled to one (1) vote with regard to the
10 promulgation of rules and creation of bylaws and shall otherwise have an
11 opportunity to participate in the business and affairs of the commission. A
12 commissioner shall vote in person or by such other means as provided in the bylaws.
13 The bylaws may provide for commissioners' participation in meetings by telephone
14 or other means of communication.

15 4. The commission shall meet at least once during each calendar year.
16 Additional meetings shall be held as set forth in the bylaws.

17 5. All meetings shall be open to the public, and public notice of meetings shall
18 be given in the same manner as required under the rulemaking provisions in sub.
19 (6).

20 6. The commission may convene in a closed, non-public meeting if the
21 commission must discuss:

22 a. Non-compliance of a compact state with its obligations under the compact;

23 b. The employment, compensation, discipline or other personnel matters,
24 practices or procedures related to specific employees or other matters related to the
25 commission's internal personnel practices and procedures;

1 c. Current, threatened, or reasonably anticipated litigation against the
2 commission;

3 d. Negotiation of contracts for the purchase or sale of goods, services or real
4 estate;

5 e. Accusation against any person of a crime or formally censuring any person;

6 f. Disclosure of trade secrets or commercial or financial information which is
7 privileged or confidential;

8 g. Disclosure of information of a personal nature where disclosure would
9 constitute a clearly unwarranted invasion of personal privacy;

10 h. Disclosure of investigatory records compiled for law enforcement purposes;

11 i. Disclosure of information related to any investigatory reports prepared by or
12 on behalf of or for use of the commission or other committee charged with
13 responsibility for investigation or determination of compliance issues pursuant to
14 the compact; or

15 j. Matters specifically exempted from disclosure by federal and state statute.

16 7. If a meeting, or portion of a meeting, is closed pursuant to this provision, the
17 commission's legal counsel or designee shall certify that the meeting may be closed
18 and shall reference each relevant exempting provision. The commission shall keep
19 minutes which fully and clearly describe all matters discussed in a meeting and shall
20 provide a full and accurate summary of actions taken, of any person participating in
21 the meeting, and the reasons therefore, including a description of the views
22 expressed. All documents considered in connection with an action shall be identified
23 in such minutes. All minutes and documents of a closed meeting shall remain under
24 seal, subject to release only by a majority vote of the commission or order of a court
25 of competent jurisdiction.

1 (c) The commission shall, by a majority vote of the commissioners, prescribe
2 bylaws and/or rules to govern its conduct as may be necessary or appropriate to carry
3 out the purposes and exercise the powers of the compact, including but not limited
4 to:

5 1. Establishing the fiscal year of the commission;

6 2. Providing reasonable standards and procedures:

7 a. For the establishment and meetings of other committees; and

8 b. Governing any general or specific delegation of any authority or function of
9 the commission;

10 3. Providing reasonable procedures for calling and conducting meetings of the
11 commission, ensuring reasonable advance notice of all meetings and providing an
12 opportunity for attendance of such meetings by interested parties, with enumerated
13 exceptions designed to protect the public's interest, the privacy of individuals of such
14 proceedings, and proprietary information, including trade secrets. The commission
15 may meet in closed session only after a majority of the commissioners vote to close
16 a meeting to the public in whole or in part. As soon as practicable, the commission
17 must make public a copy of the vote to close the meeting revealing the vote of each
18 commissioner with no proxy votes allowed;

19 4. Establishing the titles, duties and authority and reasonable procedures for
20 the election of the officers of the commission;

21 5. Providing reasonable standards and procedures for the establishment of the
22 personnel policies and programs of the commission. Notwithstanding any civil
23 service or other similar law of any compact state, the bylaws shall exclusively govern
24 the personnel policies and programs of the commission;

1 6. Promulgating a code of ethics to address permissible and prohibited
2 activities of commission members and employees;

3 7. Providing a mechanism for concluding the operations of the commission and
4 the equitable disposition of any surplus funds that may exist after the termination
5 of the compact after the payment and/or reserving of all of its debts and obligations;

6 8. The commission shall publish its bylaws in a convenient form and file a copy
7 thereof and a copy of any amendment thereto, with the appropriate agency or officer
8 in each of the compact states;

9 9. The commission shall maintain its financial records in accordance with the
10 bylaws; and

11 10. The commission shall meet and take such actions as are consistent with the
12 provisions of this compact and the bylaws.

13 (d) The commission shall have the following powers:

14 1. The authority to promulgate uniform rules to facilitate and coordinate
15 implementation and administration of this compact. The rule shall have the force
16 and effect of law and shall be binding in all compact states;

17 2. To bring and prosecute legal proceedings or actions in the name of the
18 commission, provided that the standing of any state psychology regulatory authority
19 or other regulatory body responsible for psychology licensure to sue or be sued under
20 applicable law shall not be affected;

21 3. To purchase and maintain insurance and bonds;

22 4. To borrow, accept or contract for services of personnel, including, but not
23 limited to, employees of a compact state;

24 5. To hire employees, elect or appoint officers, fix compensation, define duties,
25 grant such individuals appropriate authority to carry out the purposes of the

1 compact, and to establish the commission's personnel policies and programs relating
2 to conflicts of interest, qualifications of personnel, and other related personnel
3 matters;

4 6. To accept any and all appropriate donations and grants of money, equipment,
5 supplies, materials and services, and to receive, utilize and dispose of the same;
6 provided that at all times the commission shall strive to avoid any appearance of
7 impropriety and/or conflict of interest;

8 7. To lease, purchase, accept appropriate gifts or donations of, or otherwise to
9 own, hold, improve or use, any property, real, personal or mixed; provided that at all
10 times the commission shall strive to avoid any appearance of impropriety;

11 8. To sell, convey, mortgage, pledge, lease, exchange, abandon or otherwise
12 dispose of any property real, personal or mixed;

13 9. To establish a budget and make expenditures;

14 10. To borrow money;

15 11. To appoint committees, including advisory committees comprised of
16 members, state regulators, state legislators or their representatives, and consumer
17 representatives, and such other interested persons as may be designated in this
18 compact and the bylaws;

19 12. To provide and receive information from, and to cooperate with, law
20 enforcement agencies;

21 13. To adopt and use an official seal; and

22 14. To perform such other functions as may be necessary or appropriate to
23 achieve the purposes of this compact consistent with the state regulation of
24 psychology licensure, temporary in-person, face-to-face practice and
25 telepsychology practice.

1 (e) The executive board:

2 1. The elected officers shall serve as the executive board, which shall have the
3 power to act on behalf of the commission according to the terms of this compact.

4 1m. The executive board shall be comprised of six members:

5 a. Five voting members who are elected from the current membership of the
6 commission by the commission;

7 b. One ex-officio, nonvoting member from the recognized membership
8 organization composed of state and provincial psychology regulatory authorities.

9 2. The ex-officio member must have served as staff or member on a state
10 psychology regulatory authority and will be selected by its respective organization.

11 3. The commission may remove any member of the executive board as provided
12 in bylaws.

13 4. The executive board shall meet at least annually.

14 5. The executive board shall have the following duties and responsibilities:

22 e. Monitor compact compliance of member states and provide compliance
23 reports to the commission;

24 f. Establish additional committees as necessary; and

25 g. Other duties as provided in rules or bylaws.

1 (f) *Financing of the commission.* 1. The commission shall pay, or provide for
2 the payment of the reasonable expenses of its establishment, organization and
3 ongoing activities.

4 2. The commission may accept any and all appropriate revenue sources,
5 donations and grants of money, equipment, supplies, materials and services.

6 3. The commission may levy on and collect an annual assessment from each
7 compact state or impose fees on other parties to cover the cost of the operations and
8 activities of the commission and its staff which must be in a total amount sufficient
9 to cover its annual budget as approved each year for which revenue is not provided
10 by other sources. The aggregate annual assessment amount shall be allocated based
11 upon a formula to be determined by the commission which shall promulgate a rule
12 binding upon all compact states.

13 4. The commission shall not incur obligations of any kind prior to securing the

15 of the compact states, except by and with the authority of the compact state.

16 5. The commission shall keep accurate accounts of all receipts and
17 disbursements. The receipts and disbursements of the commission shall be subject
18 to the audit and accounting procedures established under its bylaws. However, all
19 receipts and disbursements of funds handled by the commission shall be audited
20 yearly by a certified or licensed public accountant and the report of the audit shall
21 be included in and become part of the annual report of the commission.

22 (g) *Qualified immunity, defense, and indemnification.* 1. The members,
23 officers, executive director, employees and representatives of the commission shall
24 be immune from suit and liability, either personally or in their official capacity, for
25 any claim for damage to or loss of property or personal injury or other civil liability

1 caused by or arising out of any actual or alleged act, error or omission that occurred,
2 or that the person against whom the claim is made had a reasonable basis for
3 believing occurred within the scope of commission employment, duties or
4 responsibilities; provided that nothing in this paragraph shall be construed to
5 protect any such person from suit and/or liability for any damage, loss, injury or
6 liability caused by the intentional or willful or wanton misconduct of that person.

7 2. The commission shall defend any member, officer, executive director,
8 employee or representative of the commission in any civil action seeking to impose
9 liability arising out of any actual or alleged act, error or omission that occurred
10 within the scope of commission employment, duties or responsibilities, or that the
11 person against whom the claim is made had a reasonable basis for believing occurred
12 within the scope of commission employment, duties or responsibilities; provided that
13 nothing herein shall be construed to prohibit that person from retaining his or her
14 own counsel; and provided further, that the actual or alleged act, error or omission
15 did not result from that person's intentional or willful or wanton misconduct.

16 3. The commission shall indemnify and hold harmless any member, officer,
17 executive director, employee or representative of the commission for the amount of
18 any settlement or judgment obtained against that person arising out of any actual
19 or alleged act, error or omission that occurred within the scope of commission
20 employment, duties or responsibilities, or that such person had a reasonable basis
21 for believing occurred within the scope of commission employment, duties or
22 responsibilities, provided that the actual or alleged act, error or omission did not
23 result from the intentional or willful or wanton misconduct of that person.

24 **(11) ARTICLE XI — RULEMAKING.** (a) The commission shall exercise its
25 rulemaking powers pursuant to the criteria set forth in this subsection and the Rules

1 adopted thereunder. Rules and amendments shall become binding as of the date
2 specified in each rule or amendment.

3 (b) If a majority of the legislatures of the compact states rejects a rule, by
4 enactment of a statute or resolution in the same manner used to adopt the compact,
5 then such rule shall have no further force and effect in any compact state.

6 (c) Rules or amendments to the rules shall be adopted at a regular or special
7 meeting of the commission.

8 (d) Prior to promulgation and adoption of a final rule or rules by the
9 commission, and at least sixty (60) days in advance of the meeting at which the rule
10 will be considered and voted upon, the commission shall file a notice of proposed
11 rulemaking:

- 12 1. On the website of the commission; and
- 13 2. On the website of each compact states' psychology regulatory authority or
14 the publication in which each state would otherwise publish proposed rules.

15 (e) The notice of proposed rulemaking shall include:

- 16 1. The proposed time, date, and location of the meeting in which the rule will
17 be considered and voted upon;
- 18 2. The text of the proposed rule or amendment and the reason for the proposed
19 rule;
- 20 3. A request for comments on the proposed rule from any interested person; and
- 21 4. The manner in which interested persons may submit notice to the
22 commission of their intention to attend the public hearing and any written
23 comments.

1 (f) Prior to adoption of a proposed rule, the commission shall allow persons to
2 submit written data, facts, opinions and arguments, which shall be made available
3 to the public.

4 (g) The commission shall grant an opportunity for a public hearing before it
5 adopts a rule or amendment if a hearing is requested by:

6 1. At least twenty-five (25) persons who submit comments independently of
7 each other;

8 2. A governmental subdivision or agency; or

9 3. A duly appointed person in an association that has having at least
10 twenty-five (25) members.

11 (h) If a hearing is held on the proposed rule or amendment, the commission
12 shall publish the place, time, and date of the scheduled public hearing.

13 1. All persons wishing to be heard at the hearing shall notify the executive
14 director of the commission or other designated member in writing of their desire to
15 appear and testify at the hearing not less than five (5) business days before the
16 scheduled date of the hearing.

17 2. Hearings shall be conducted in a manner providing each person who wishes
18 to comment a fair and reasonable opportunity to comment orally or in writing.

19 3. No transcript of the hearing is required, unless a written request for a
20 transcript is made, in which case the person requesting the transcript shall bear the
21 cost of producing the transcript. A recording may be made in lieu of a transcript
22 under the same terms and conditions as a transcript. This subdivision shall not
23 preclude the commission from making a transcript or recording of the hearing if it
24 so chooses.

1 4. Nothing in this paragraph shall be construed as requiring a separate hearing
2 on each rule. Rules may be grouped for the convenience of the commission at
3 hearings required by this paragraph.

4 (i) Following the scheduled hearing date, or by the close of business on the
5 scheduled hearing date if the hearing was not held, the commission shall consider
6 all written and oral comments received.

7 (j) The commission shall, by majority vote of all members, take final action on
8 the proposed rule and shall determine the effective date of the rule, if any, based on
9 the rulemaking record and the full text of the rule.

10 (k) If no written notice of intent to attend the public hearing by interested
11 parties is received, the commission may proceed with promulgation of the proposed
12 rule without a public hearing.

13 (L) Upon determination that an emergency exists, the commission may
14 consider and adopt an emergency rule without prior notice, opportunity for
15 comment, or hearing, provided that the usual rulemaking procedures provided in the
16 compact and in this paragraph shall be retroactively applied to the rule as soon as
17 reasonably possible, in no event later than ninety (90) days after the effective date
18 of the rule. For the purposes of this provision, an emergency rule is one that must
19 be adopted immediately in order to:

- 20 1. Meet an imminent threat to public health, safety, or welfare;
- 21 2. Prevent a loss of commission or compact state funds;
- 22 3. Meet a deadline for the promulgation of an administrative rule that is
23 established by federal law or rule; or
- 24 4. Protect public health and safety.

1 (m) The commission or an authorized committee of the commission may direct
2 revisions to a previously adopted rule or amendment for purposes of correcting
3 typographical errors, errors in format, errors in consistency, or grammatical errors.
4 Public notice of any revisions shall be posted on the website of the commission. The
5 revision shall be subject to challenge by any person for a period of thirty (30) days
6 after posting. The revision may be challenged only on grounds that the revision
7 results in a material change to a rule. A challenge shall be made in writing, and
8 delivered to the chair of the commission prior to the end of the notice period. If no
9 challenge is made, the revision will take effect without further action. If the revision
10 is challenged, the revision may not take effect without the approval of the
11 commission.

12 **(12) ARTICLE XII — OVERSIGHT, DISPUTE RESOLUTION AND ENFORCEMENT.** (a)
13 *Oversight.* 1. The executive, legislative and judicial branches of state government
14 in each compact state shall enforce this compact and take all actions necessary and
15 appropriate to effectuate the compact's purposes and intent. The provisions of this
16 compact and the rules promulgated hereunder shall have standing as statutory law.

17 2. All courts shall take judicial notice of the compact and the rules in any
18 judicial or administrative proceeding in a compact state pertaining to the subject
19 matter of this compact which may affect the powers, responsibilities or actions of the
20 commission.

21 3. The commission shall be entitled to receive service of process in any such
22 proceeding, and shall have standing to intervene in such a proceeding for all
23 purposes. Failure to provide service of process to the commission shall render a
24 judgment or order void as to the commission, this compact or promulgated rules.

1 (b) *Default, technical assistance, and termination.* 1. If the commission
2 determines that a compact state has defaulted in the performance of its obligations
3 or responsibilities under this compact or the promulgated rules, the commission
4 shall:

5 a. Provide written notice to the defaulting state and other compact states of the
6 nature of the default, the proposed means of remedying the default and/or any other
7 action to be taken by the commission; and

8 b. Provide remedial training and specific technical assistance regarding the
9 default.

10 2. If a state in default fails to remedy the default, the defaulting state may be
11 terminated from the compact upon an affirmative vote of a majority of the compact
12 states, and all rights, privileges and benefits conferred by this compact shall be
13 terminated on the effective date of termination. A remedy of the default does not
14 relieve the offending state of obligations or liabilities incurred during the period of
15 default.

16 3. Termination of membership in the compact shall be imposed only after all
17 other means of securing compliance have been exhausted. Notice of intent to
18 suspend or terminate shall be submitted by the commission to the governor, the
19 majority and minority leaders of the defaulting state's legislature, and each of the
20 compact states.

21 4. A compact state which has been terminated is responsible for all
22 assessments, obligations and liabilities incurred through the effective date of
23 termination, including obligations which extend beyond the effective date of
24 termination.

1 5. The commission shall not bear any costs incurred by the state which is found
2 to be in default or which has been terminated from the compact, unless agreed upon
3 in writing between the commission and the defaulting state.

4 6. The defaulting state may appeal the action of the commission by petitioning
5 the U.S. District Court for the state of Georgia or the federal district where the
6 compact has its principal offices. The prevailing member shall be awarded all costs
7 of such litigation, including reasonable attorney's fees.

8 (c) *Dispute resolution.* 1. Upon request by a compact state, the commission
9 shall attempt to resolve disputes related to the compact which arise among compact
10 states and between compact and non-compact states.

11 2. The commission shall promulgate a rule providing for both mediation and
12 binding dispute resolution for disputes that arise before the commission.

13 (d) *Enforcement.* 1. The commission, in the reasonable exercise of its
14 discretion, shall enforce the provisions and rules of this compact.

15 2. By majority vote, the commission may initiate legal action in the United
16 States District Court for the State of Georgia or the federal district where the
17 compact has its principal offices against a compact state in default to enforce
18 compliance with the provisions of the compact and its promulgated rules and bylaws.
19 The relief sought may include both injunctive relief and damages. In the event
20 judicial enforcement is necessary, the prevailing member shall be awarded all costs
21 of such litigation, including reasonable attorney's fees.

22 3. The remedies herein shall not be the exclusive remedies of the commission.
23 The commission may pursue any other remedies available under federal or state law.

24 **(13)** ARTICLE XIII — DATE OF IMPLEMENTATION OF THE PSYCHOLOGY
25 INTERJURISDICTIONAL COMPACT COMMISSION AND ASSOCIATED RULES, WITHDRAWAL, AND

1 AMENDMENTS. (a) The compact shall come into effect on the date on which the compact
2 is enacted into law in the seventh compact state. The provisions which become
3 effective at that time shall be limited to the powers granted to the commission
4 relating to assembly and the promulgation of rules. Thereafter, the commission shall
5 meet and exercise rulemaking powers necessary to the implementation and
6 administration of the compact.

7 (b) Any state which joins the compact subsequent to the commission's initial
8 adoption of the rules shall be subject to the rules as they exist on the date on which
9 the compact becomes law in that state. Any rule which has been previously adopted
10 by the commission shall have the full force and effect of law on the day the compact
11 becomes law in that state.

12 (c) Any compact state may withdraw from this compact by enacting a statute
13 repealing the same.

14 1. A compact state's withdrawal shall not take effect until six (6) months after
15 enactment of the repealing statute.

16 2. Withdrawal shall not affect the continuing requirement of the withdrawing
17 state's psychology regulatory authority to comply with the investigative and adverse
18 action reporting requirements of this act prior to the effective date of withdrawal.
