2021 SENATE BILL 632

1 **AN ACT relating to:** funding for the University of Wisconsin System, special
2 education funding, and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill provides additional funding for the University of Wisconsin System under its general program operations appropriation.

The bill also provides additional funding for special education aid the Department of Public Instruction pays to school districts, independent charter schools, cooperative educational service agencies, and county children with disabilities education boards, for purposes of maintaining compliance with maintenance of effort requirements of the federal Consolidated Appropriations Act and the federal American Rescue Plan Act.

3 **SECTION 1. Fiscal changes.**

4 (1) UNIVERSITY OF WISCONSIN SYSTEM; GENERAL PROGRAM OPERATIONS. In the

5 appropriation is made.

6 (2) SPECIAL EDUCATION AID. In the schedule under s. 20.005 (3) for the
7 appropriation to the department of public instruction under s. 20.255 (2) (b), the
8 dollar amount for fiscal year 2021-22 is increased by \$4,525,000 to increase funding
9 for aids for special education under s. 115.88 and the dollar amount for fiscal year
10 2022-23 is increased by \$4,525,000 to increase funding for aids for special education
11 under s. 115.88.
