Analysis by the Legislative Reference Bureau

This bill directs the joint committee on legislative organization to contract for a bas-relief plaque, to be prepared by a suitable sculptor, to display a representation of Dr. H. Rupert Theobald, former chief of the legislative reference bureau, honoring Dr. Theobald's public service, for placement in the assembly chamber. The bill appropriates \$5,000 in general purpose revenue for this purpose.
