



## 2005 SENATE JOINT RESOLUTION 27

June 14, 2005 – Introduced by Senators KANAVAS, ZIEN, LEIBHAM, A. LASEE, DARLING, BROWN, OLSEN, ROESSLER, SCHULTZ, RISSER, CARPENTER and KEDZIE, cosponsored by Representatives DAVIS, GARD, NISCHKE, GUNDRUM, KESTELL, FREESE, HAHN, J. FITZGERALD, HUNDERTMARK, PETROWSKI, OTT, TOWNSEND, OWENS, ALBERS, VAN ROY, KRAWCZYK, STRACHOTA, LOTHIAN, PETTIS, SEIDEL, SINICKI, LEHMAN, VAN AKKEREN, BIES, HEBL, TURNER, KREUSER, TRAVIS, McCORMICK, KREIBICH, GUNDERSON and NASS. Referred to Committee on Veterans, Homeland Security, Military Affairs, Small Business and Government Reform.

1     **Relating to:** Wisconsin Department of Veterans Affairs 60 Years of Service to  
2           Veterans.

3           Whereas, soon after the attack on Pearl Harbor, Wisconsin began planning for  
4     the return to civilian life of all men and women who were to serve in the armed forces;  
5     and

6           Whereas, not knowing how long the war would last but that one day those who  
7     served would come home and that its people would be prepared to extend every  
8     possible assistance to restore them to their proper place in a grateful and peaceful  
9     society; and

10          Whereas, in 1943, Wisconsin legislation created the Veterans' Recognition  
11     Board to provide medical, hospital, education, and economic aid to returning  
12     Wisconsin veterans of World War II and their dependents; and

13          Whereas, during the 1945 legislative session that department and several  
14     other state departments concerned with veterans affairs were integrated into a  
15     single department—the Wisconsin Department of Veterans Affairs—combining into

1 one department the powers, duties, and functions previously assigned to the  
2 separate agencies; and

3 Whereas, during the 1945 legislative session a law enacted made it mandatory  
4 for each county board to appoint a county veterans service officer; and

5 Whereas, similar to the period during and immediately following the Second  
6 World War, the State of Wisconsin has seen fit to provide assistance to all returning  
7 veterans and families, with the current initiative entitled "Mission: Welcome Home,"  
8 a program to reintegrate our Wisconsin Iraqi Freedom and Enduring Freedom  
9 veterans back to Wisconsin; and

10 Whereas, over the past 60 years, under seven Secretaries of Veterans Affairs,  
11 the Wisconsin Department of Veterans Affairs has not wavered in its support to  
12 Wisconsin veterans, from World War II to the present, and has continued to maintain  
13 the most comprehensive array of state veterans benefits of any state, while also  
14 working to ensure Wisconsin veterans learn about and receive the benefits and  
15 services they have rightfully earned; now therefore, be it

16 ***Resolved by the senate, the assembly concurring, That*** the Wisconsin  
17 Department of Veterans Affairs is congratulated on its 60 years of service to  
18 Wisconsin veterans; and, be it further

19 ***Resolved, That*** the senate chief clerk shall transmit a copy of this joint  
20 resolution to the Secretary of Veterans Affairs.
