SENATE BILL 1

February 5, 2020 - Introduced by COMMITTEE ON SENATE ORGANIZATION, by request of Governor Tony Evers. Referred to Committee on Agriculture, Revenue and Financial Institutions.

- 1 **AN ACT to create** 20.115 (3) (f) and 93.525 of the statutes; **relating to:** providing
2 planning assistance to farmers and making an appropriation.

Analysis by the Legislative Reference Bureau

Under this bill, the Department of Agriculture, Trade and Consumer Protection provides planning assistance to farmers, including farmers seeking to transition into other farming practices to diversify farm operations, as follows:

1. The bill authorizes a position in DATCP for providing assistance to farmers considering a transition to different farming practices and identifying diversification strategies for farmers.

2. The bill authorizes 1.5 positions in DATCP to provide farm succession planning, financial and business consulting services, and farmer transition planning and coaching. Under current law, DATCP provides consultation and assistance to distressed farmers through its farm center program.

3. The bill authorizes a position in DATCP for conducting outreach and marketing for DATCP's farm center program.

4. The bill requires DATCP to provide grants to county agriculture agents of the University of Wisconsin-Extension to help farm operators hire business consultants to examine their farm business plans.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 20.005 (3) (schedule) of the statutes: at the appropriate place, insert
2 the following amounts for the purposes indicated:

8 **SECTION 2.** 20.115 (3) (f) of the statutes is created to read:

9 20.115 (3) (f) *Grants for hiring business consultants.* As a continuing
10 appropriation, the amounts in the schedule for providing grants under s. 93.525 to
11 county agriculture agents to help farm operators hire business consultants to
12 examine farm business plans.

13 **SECTION 3.** 93.525 of the statutes is created to read:

14 **93.525 Grants for hiring business consultants.** From the appropriation
15 under s. 20.115 (3) (f), the department shall provide grants to county agriculture
16 agents of the University of Wisconsin-Extension to help farm operators hire
17 business consultants to examine their farm business plans.

18 **SECTION 4. Fiscal changes.**

19 (1) FARM SUCCESSION PLANNING AND CONSULTING SERVICES. In the schedule under
20 s. 20.005 (3) for the appropriation to the department of agriculture, trade and
21 consumer protection under s. 20.115 (3) (a), the dollar amount for fiscal year 2020-21
22 is increased by \$135,900 to increase the authorized FTE positions for the department
23 by 1.5 GPR positions for providing farm succession planning, financial and business

1 consulting services, and farmer transition planning and coaching. In the schedule
2 under s. 20.005 (3) for the appropriation to the department of agriculture, trade and
3 consumer protection under s. 20.115 (3) (a), the dollar amount for fiscal year 2020-21
4 is increased by \$24,000 to provide supplies and services for the positions authorized
5 under this subsection.

6 (2) FARM CENTER OUTREACH SPECIALIST. In the schedule under s. 20.005 (3) for
7 the appropriation to the department of agriculture, trade and consumer protection
8 under s. 20.115 (3) (a), the dollar amount for fiscal year 2020-21 is increased by
9 \$90,600 to increase the authorized FTE positions for the department by 1.0 GPR
10 position for conducting outreach and marketing for the department's farm center
11 program. In the schedule under s. 20.005 (3) for the appropriation to the department
12 of agriculture, trade and consumer protection under s. 20.115 (3) (a), the dollar
13 amount for fiscal year 2020-21 is increased by \$50,000 to provide supplies and
14 services for the position authorized under this subsection.

15 (3) FARM CENTER BUSINESS DEVELOPMENT SPECIALIST. In the schedule under s.
16 20.005 (3) for the appropriation to the department of agriculture, trade and
17 consumer protection under s. 20.115 (3) (a), the dollar amount for fiscal year 2020-21
18 is increased by \$90,600 to increase the authorized FTE positions for the department
19 by 1.0 GPR position for providing assistance to farmers considering a transition to
20 different farming practices and identifying diversification strategies for farmers,
21 including by working with small business development centers that are part of the
22 University of Wisconsin System and similar entities. In the schedule under s. 20.005
23 (3) for the appropriation to the department of agriculture, trade and consumer
24 protection under s. 20.115 (3) (a), the dollar amount for fiscal year 2020-21 is

1 increased by \$30,000 to provide supplies and services for the position authorized
2 under this subsection.
