Chap 28. An Act declaring certain roads in the town of Shields lawful highways.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

To prepare
copies of sur-
vey bills.

SECTION 1. That it shall be the duty of the town clerk of the town of Emmet, immediately after the passage of this act, to prepare certified copies of the survey bills of all roads in the town of Shields on file in his office, which shall not have been discontinued, and deliver the same to the town clerk of the town of Shields when called upon by him for that purpose.

lawful.

SEC. 2. It shall be the duty of the town clerk of Shields, immediately after the passage of this act, to call upon the town clerk of the town of Emmet and obtain the copies mentioned in the first section of this act, and record the same in his office, and when so recorded, they are hereby declared to be lawful highways, and shall be opened and kept in repair the same as other town and county roads.

SEC. 3. This act shall take effect from and after its passage.

Chap 29. An Act to extend the time for collecting and returning taxes in the town of Taycheda in the county of Fond du Lac.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Taychedah.

SECTION 1. The time for collecting the town, county, and state taxes for the year one thousand eight hundred and forty-eight, in the town of Taycheda, in the county of Fond du Lac, and paying over the same to the treasurer, is hereby extended until the first day of April next.

SEC. 2. The collector of said town is hereby invested with all

powers necessary by law for collecting the same, until the first day of April next.

An Act to constitute certain persons members of the Milwaukee Cemetery Association. Chap 30.

THE People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. All persons who, previous to the passage of an act of the legislature of the State of Wisconsin, entitled "an act to incorporate the Milwaukee Cemetery Association of the City of Milwaukee, approved August 16th, 1848," were owners of lots laid out for burial purposes in any of the land mentioned and described in said act of incorporation, shall be deemed members of said corporation, and shall be entitled to all the privileges and be subject to all the duties of persons becoming members of the said corporation since the passage of said act. An Act relating to Courts of Record in this State.

Chap 31.

THE People of the State of Wisconsin represented in Senate and Assembly, do enact as follows:

SECTION 1. All process issuing out of any court of record in this State, shall be sealed with the seal of the court from which it issues, and the clerks of the several courts of record in this state are hereby authorized to issue and deliver to any attorney of their respective courts, blank process and seals to be used in sealing process, under such rules as may be prescribed by the supreme or circuit courts. Processes.

SEC. 2. The judges of the supreme court are hereby authorized to make such rules in regard to the issuing and return of process, and also to regulate the manner in which judgments may be entered in the supreme or circuit courts, as they may deem proper, which rules shall be uniform, as near as may be, throughout the state.
