CHAPTER 181.

[Iublished April 11, 1861.]

AN ACT to provide for the disposal and expenditure of the Drainage Fund Income in the counties of Adams and Fond du Lac.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

When interest to be paid.

SECTION 1. That portion of the interest of the drainage fund income which shall hereafter become due, or which is now due, to the county of Adams and the county of Fond du Lac, shall be paid over to the county treasurer of each of said counties at the same time with the money due to each of said counties from the school fund income for each year.

How apportioned. Section 2. It shall be the duty of the county treasurer of each of said counties, immediately upon the receipt of the said drainage money, to apportion the same among the several towns of each of said counties, in proportion to the number of acres of swamp and overflowed lands in each of said towns respectively; and he shall immediately give notice, in writing, to the town clerk of each town in each of said counties, of the amount apportioned to his town; and the town clerk of each such town shall thereupon file in his office such statement of the apportionment, and notify the town board of supervisors of his town that such apportionment has been made, and of the amount of such apportionment.

How expended.

SECTION 3. The said money when apportioned as aforesaid, shall be under the control of the town board of supervisors of each such town respectively, and shall be expended, under their direction, in the drainage and

reclamation of the swamp and overflowed lands in their respective towns, and in building roads and bridges, when they shall deem it necessary, over or through the The town board is hereby authorized to draw and issue orders on the county treasurer in the same manner and form in which they are authorized to draw and issue orders on the town treasurer to the amount of the drainage fund in his hands: provided, that said Proviso. board shall issue such orders only for the payment of labor actually done, or material furnished for the purposes designated in this section, or for the payment of their own time actually employed in the performance of the duties enjoined by this act.

SECTION 4. Each member of the board shall be en- Compensation. titled to receive the sum of one dollar for each and every day actually employed in the performance of the duties enjoined by this act, to be defrayed out of the drainage fund of such town.

SECTION 5. The town board of each town in each Report to be of said counties, shall, on the second day of the annual session of the county board of supervisors of each of said counties, make a full and complete report to the said county board, of the receipts and disbursements of the said drainage money apportioned to their respective towns.

SECTION 6. It shall be the duty of the county board Report to State treasurer. of supervisors of each of said counties to make to the state treasurer a full report of the disbursements of said fund on or before the tenth day of December of each year.

SECTION 7. All moneys belonging to the drainage Appropriation of fund income heretofore paid to the treasurer of each ot said counties, and not yet expended, shall be apportioned and divided among the several towns in each of said counties, in the same manner as moneys hereafter to become due to each of said counties, arising from the drainage fund; and in case the drainage money heretofore paid to the treasurer of each of said counties, has passed into the hands of the drainage commissioner of each of said counties, the said county treasurer of each of said counties, shall notify said commissioner to return the same to the said county treasurer, so that the same may be apportioned as aforesaid; and it shall be the duty of the said commissioner to immediately return and pay over to said treasurer all moneys belonging to

said fund which are in his hands or subject to his control at the time said notice shall be served on him. All acts and parts of acts which contravene the provisions of this act, are hereby repealed.
