CHAPTER 262.

[Published April 29, 1861.]

AN ACT to enable the Regents of the State University to complete and furnish University Hall.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

Bonds to be issued-where payable and when redeemable.

Section 1. The commissioners of the school and university lands are hereby authorized and directed to issued (35) thirty-five bonds, to be designated "state university income bonds," numbered from one to thirtyfive, of the amount of (\$1,000) one thousand dollars each, bearing interest at seven per cent. per annum, payable semi-annually, by the state treasurer, out of the income of said fund, in the city of New York, said bonds redeemable at his office, according to the tenor of said bond, viz: The first bond on the first day of June, 1866, and one bond yearly thereafter, until the the first day of June, 1886, when the remainder of said bonds shall be paid and canceled, and to deliver such bonds to the treasurer of the regents of the university.

Interest to be retained from

SECTION 2. The state treasurer is hereby directed to university fund. retain each year, out of any income of the university fund, a sum sufficient to pay the semi-annual interest on the bonds issued, and to redeem any one of such bonds as shall mature within the year, and to pay such interest and redeem such bonds according to the tenor thereof, and the provisions of section one of this act.

Bonds not to be soid at less than

Section 3. The regents of the university are hereby authorized to dispose of said bonds, at not less than their par value, and to apply the avails thereof to any indebtedness which has been or may be incurred in the erection of university hall and fitting up the same for use.

Appropriation.

Section 4. There is hereby appropriated out of the income of said fund, as provided for in this act, a sufficient sum of money to pay interest on said bonds and the principal as fast as the same shall become due.

SECTION 5. This act shall take effect and be in force from and after its passage.

AN ACT to authorize the purchase of one thousand copies of the first volume of the Geological Reports of this state.

The People of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The governor of the state is hereby Size of volume, authorized and directed to purchase of Professor James brace. Hall one thousand copies of the first volume of his geological report of Wisconsin, confined mainly to the lead region, and to contain between four and five hundred pages. The said volume shall embrace a chapter on the general geology of the state, and its relations to the geology of the surrounding states, with the details of the geology, mineralogy and mining thereof, and shall be the same size, and in all respects as to type, paper and binding, equal to the Iowa geological report, with all necessary maps and illustrations: provided, that Price. said one thousand copies, delivered at the capitol in the city of Madison, shall not cost more than three dollars each.

SECTION 2. The governor shall designate in the If not according contract for such purchase, the time for the delivery not liable. of said copies; and in case the same do not answer the requirements of the contract, as indicated in section one of this act, the state shall be under no obligation to accept the same, nor shall any liability on account thereof exist against the state.

SECTION 3. The cost of the said copies shall be paid When to be paid. by the treasurer of the state on the warrant of the governor, when the said one thousand copies shall have been delivered and accepted, and the sum of three thousand dollars is hereby appropriated out of any
