

CHAPTER 29.

[Published February 17, 1865.]

AN ACT to amend an act entitled "an act to amend chapter 27 of the revised statutes, entitled 'of the state superintendent of public property, and the purchase and distribution of stationery for the use of the state.'"

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section one of the act to which this is amendatory, is hereby amended, by striking out the word "fifteen," when it occurs in said section, and inserting the word "thirty," so that the proviso in said section will read: "Provided, that the amount of stationery furnished in any one year to each and every member of the legislature, the lieutenant governor, and sergeant-at-arms of each house, shall not exceed in value thirty dollars." Stationery to amount of \$30 to members, &c.

SECTION 2. This act shall take effect from and after its passage.

CHAPTER 30.

[Published February 17, 1865.]

AN ACT to authorize the payment of certain claims from the war fund.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. All expenses for clerk hire or any other purpose, which shall be necessarily incident to the payment and distribution of the extra pay provided by chapter 117, laws of 1864, and all expenses necessarily incurred in conducting the business of the offices of adjutant-general and quartermaster-general, respectively, including the salaries of the adjutant-general and quartermaster-general, shall be paid from the war fund. Clerks payable from war fund.

SECTION 2. It shall be the duty of the secretary of state to draw his warrant on the state treasurer, pay- Warrants

able from the war fund, for all claims audited under the provisions of section one (1) of this act.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

AN ACT to amend an act entitled "an act to incorporate the Peabigo lumbering and manufacturing company," approved October 11th, 1858, and the acts amendatory thereof.

CHAPTER 32.

[Published February 18, 1865.]

AN ACT to provide for the payment of mileage to the regents of the university of Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Mileage to regents.

SECTION 1. The regents of the university of Wisconsin, for every mile they shall travel in going to and returning from the place of the annual meeting of said regents, on the most direct and usual routes of travel, shall be entitled to receive the same mileage as members of the legislature: *provided*, that the amount of mileage paid to any of said regents in one year, shall not exceed fifty dollars.

Yearly limit.

Appropriation.

SECTION 2. There is hereby appropriated out of any money in the state treasury belonging to the university fund income, not otherwise appropriated, a sufficient sum to pay the mileage to regents of the university, as provided by section one of this act.
