Territory added to joint school district of Aztalan and Jefferson.

SECTION 2. The south one-half of the southeast quarter of section number four, in said town and range, is hereby made a part of joint school district number four, of the towns of Aztalan and Jefferson, in said county.

Repealed.

SECTION 3. All acts or parts of acts heretofore passed inconsistent with this act are hereby repealed.

SECTION 4. This act shall be published in the Jefferson Banner, a newspaper published in the city of Jefferson, Jefferson county Wisconsin, and shall take effect from and after its passage and publication.

#### CHAPTER 198.

AN ACT relating to the killing of deer in Door county, and amendatory of section four, chapter forty, of the laws of 1879.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Amended.

SECTION 1. Amend said section four of chapter forty, as follows: Strike out all after the word "county," in the sixth line, and insert in lieu thereof the following: No person or persons shall be allowed to hunt, worry or kill any buck, doe or fawn after night-fall, by the aid of any police lantern, torch light, or any other artificial light.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

#### CHAPTER 199.

AN ACT to amend section one hundred and sixty-nine, chapter eleven of the revised statutes, entitled "of the state officers."

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

Department's entitled postage stamps.

SECTION 1. Section one hundred and sixty-nine of the revised statutes, entitled "of the state officers," is hereby amended by inserting after the words "state

historical society," in the third and fourth lines of said section, the words "secretary of the state agricultural society," so that the said section when so amended shall read as follows: Section 169. The governor, secretary of state, state treasurer, attorney general, state superintendent, superintendent of public property, clerk of the supreme court, corresponding secretary of the state historical society, secretary of the state agricultural society, railroad commissioner, commissioner of insurance and state board of charities and reform, adjutant general, quarter-master general, and state treasury agent, are authorized to procure for the use of their respective offices the necessary amount of postage stamps or stamped envelopes for the payment of the postage of the official correspondence of their several departments. The accounts therefor shall be audited by the secretary of state upon the presentation thereof in the manner hereinbefore provided, and paid out of the state treasury.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

### CHAPTER 200.

AN ACT to amend subdivision one of section three hundred and thirty-nine of chapter twenty of the revised statutes, entitled of public printing.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. Subdivision one of section three hundred and thirty-nine is hereby amended by striking out the word "five," in the first line of said subdivision, and inserting the word "seven," so that said subdivision, when so amended, will read as follows: 1. Seven thousand copies of the transactions of the Wisconsin agricultural society, together with abstracts of the reports of the county agricultural societies, and such other matters pertaining to the industry of the state as shall be deemed important.

Seven thousand copies of annual report of Agricultural Society.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
