SECTION 6. A majority of the directors of any such corporation must be citizens of the state of Wisconsin, and each director must be a stockholder to the amount of five thousand dollars at least. Qualification of stockholder.

SECTION 7. All acts contravening the provisions of this act are hereby repealed.

SECTION 8. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 34.

AN ACT to appropriate to the Columbia County Agricultural society a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is hereby appropriated to the Columbia County Agricultural Society, out of any money in the general fund not otherwise appropriated, the sum of one hundred dollars for the year A. D. 1884. Appropriation \$100.

AN ACT to appropriate to the governor's contingent fund a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is hereby appropriated to the governor of the state of Wisconsin, out of any Appropriation \$2,000.

CHAPTER 36.

AN ACT to appropriate to the Wisconsin State Horticultural Society a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Appropriation,
\$2,000.

SECTION 1. There is hereby appropriated to the Wisconsin State Horticultural Society the sum of two thousand dollars, out of any money in the state treasury not otherwise appropriated. This appropriation is made to cover the years of 1885 and 1886, and shall be paid to said society in two annual equal payments, viz.: in 1885 and 1886.
