

said slide or chute open at all times when the said river is at a driving stage, and there are logs and timber to run over said dam.

SECTION 2. The dam so erected shall be subject to all the provisions of chapter 146, of the revised statutes, and acts amendatory thereof, so far as said chapter and acts amendatory may be applied, in like manner as if such provisions were incorporated in this act. Subject to provisions of law.

SECTION 3. The right to alter, amend, or repeal this act is hereby reserved.

SECTION 4. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 403.

AN ACT to authorize O. R. Johnson and others to construct and maintain a bridge across Root river, in Racine county, Wisconsin.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. O. R. Johnson, L. S. Blake, W. P. Packard, Hugh Gorton and J. R. Slauson, their heirs and assigns, are hereby authorized, and empowered to build and maintain a bridge across Root river, on the section line between sections eight and seventeen, town three north, range twenty-three east, in the town of Mt. Pleasant, Racine county, Wisconsin, said bridge to be completed on or before the first day of June, 1886, and they are hereby authorized to charge the following rates of toll over said bridge when constructed: For a team of horses or oxen driven in a pair or team, ten cents; for a single horse with vehicle, five cents; horse and rider, five cents; for horses not attached to any vehicle and neat cattle, two cents per head; for swine and sheep, one cent per head; for foot passengers, two cents for each person; for children from five to ten years of age, one cent. Authorized to build a bridge.

Grade of highway to be established.

SECTION 2. Said individuals, their heirs and assigns, may also, with the assent of the supervisors of said town of Mt. Pleasant, or a majority of them, change and establish the grade of the highway leading from the proposed bridge, from the quarter line of the aforesaid section to the city limits of the city of Racine.

City or town may purchase said bridge.

SECTION 3. The city of Racine shall have the privilege of purchasing said bridge and necessary improvements from the owners thereof, at an appraised value, by three competent and disinterested persons, either agreed upon or appointed by the county court of Racine county, from which appraisal there shall be no appeal. This purchase may take place at any time after the limits of such city shall be extended so as to include the same, upon giving to such owners three months notice of their intention to make such purchase. The town of Mt. Pleasant aforesaid shall have like privilege of purchasing said bridge and improvements upon like conditions.

SECTION 4. This act shall be in force from and after its passage and publication.

CHAPTER 404.

AN ACT to provide for issuing and distribution of reports.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows :

Report of National Guard of Wisconsin how distributed.

SECTION 1. Three thousand copies of the report of the proceedings of the annual convention of officers of the Wisconsin National Guard shall be printed by the state printer each year, and delivered to the adjutant general for distribution from his office as follows: To each company, troop or battery, fifty copies; to each commissioned officer, three copies; to each state officer and member of the legislature, one copy; and the remainder to the adjutant general for distribution at his discretion;
