taxable property of said county, sufficient to raise the amount due on said certificates, and cause the same to be collected with the tax of that year.

Section 10. Said commissioners shall not be commissioners individually responsible on account of anything by responsible. them done, or any contract entered into by them as such commissioners in attempting to carry out the provisions of this act.

SECTION 11. Said commissioners are hereby Term of comgiven the term of five years from the date of the five years. passage of this act, for the laying out and establishing this road and building such bridges.

Section 12. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 463.

AN ACT relating to police regulations in unincorporated villages, and amendatory of section 1, chapter 19, general laws of 1881.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 1, of chapter 19, of the gen-Relating to police real laws of 1881, is hereby amended, by inserting in unincorporafter the word, "village," where it occurs in said rated villages. section, the words, "of not less than three hundred inhabitants, within limits to be designated by such town board, and recorded in the town clerk's office;" also, by inserting after the word, "government," where it occurs in said section, the words, "and for the purpose of restraining drunkenness, disorderly conduct and the careless use of fire-arms, such town board shall have authority to pass such by-laws as it may deem expedient, and fix a penalty, not exceeding ten dollars, for any one violation of the same, and such bylaws shall be published and shall be binding as are by-laws, passed by qualified electors, at an annual town meeting," so that said section, when so amended, shall read as follows: The town board of any town, containing an un-

incorporated village, of not less than three hundred inhabitants, within limits to be designated by such town board, and recorded in the town clerk's office, may, when in its discretion the public good requires, appoint not exceeding three policemen, one night watchman and one superintendent of police, and prescribe their duties, and make bylaws for their government; and for the purpose of restraining drunkenness, disorderly conduct and the careless use of fire arms, such town board shall have authority to pass such by-laws as it may deem expedient, and fix a penalty, not exceeding ten dollars for any one violation of the same, and such by-laws shall be published, and shall be binding, as are by laws passed by qualified electors at an annual town meeting. And said policemen, night watchman and superintendent. shall have the same powers as are now conferred by law upon constables.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 464.

AN ACT relating to elections and the counting and preservation of ballots.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Duties of persons whose vote is challenged.

SECTION 1. Whenever at any election the right of any person offering to vote is challenged for any cause recognized by law, if the inspectors shall determine to receive the vote of the party challenged after the provisions of the law are complied with, such inspectors, before depositing the ticket of the party challenged in the ballot box, shall write or cause to be written upon the back of the ticket of the voter challenged, the number of such challenged person upon the tally sheet or voting list kept at such election.

SECTION 2. At every election hereafter held within this state, the inspectors of election shall
