Section 1636—139. Upon complaint to the commissioner of labor, factory inspector or assistant inspector, it shall be his duty to enforce the provisions of this act.

SECTION 2. All acts or parts of acts in conflict with the provisions of this act are hereby repealed.

SECTION 3. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 140.

AN ACT to appropriate to Grace Usher a sum of money therein named.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is appropriated to Grace Usher out of any moneys in the treasury, not otherwise appropriated, the sum of five hundred dollars as compensation for injuries received by her July 27, 1908, by being thrown and falling, without fault or negligence on her part, while attending an entertainment given by the Ben Greet players on the university grounds at Madison advertised on the programme of the university of Wisconsin summer school, the said injury being caused by the collapse of defectively constructed elevated seats.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 141.

AN ACT to amend paragraph (f) of subsection 19 of section 170, section 645 and section 649—19a of the statutes, relating to the Wisconsin National Guard.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Paragraph (f) of subsection 19 of section 170, section 645 and section 649—19a of the statutes are amended to read: (Section 170) (19) (f). The assistant quartermaster
* * * *eighteen* hundred dollars.

Section 645. 1. Each commanding officer to whom state military property is issued shall execute to the state a bond, with such sureties and in such form as the governor shall approve, and in a sum not less than double the value of such arms, accoutrements or stores furnished, conditioned for the faithful preservation and care of all such arms, accoutrements, moneys, or stores, as shall be by him received, to indemnify the state against loss by misuse or misapplication of any part thereof by himself or any other person; to account for all of the same according to law, and to deliver the same to any officer lawfully entitled thereto, on demand, and to pay all sums lawfully appraised for losses or damages. Thereupon the quartermaster general shall issue such arms, accoutrements and stores as the governor shall by order direct, which shall be as nearly as possible like those in use in the army of the United States.

2. The commanding officer for the time being is the legal custodian of the money, property and effects of any company, band, regiment or brigade of the National Guard, whether said property is owned by said company, band, or regiment or brigade, or its members collectively, or has been issued to it or any of its officers, for its use by state or United States authority, and may sue for and recover possession of the same, whenever wrongfully withheld from his custody or the custody of the company, band, regiment or brigade.

3. The adjutant general, with the approval of the governor, may obtain and pay for out of the annual military appropriation an adequate indemnity bond covering all of the officers of the Wisconsin National Guard responsible to the state for moneys and military property.

4. *Each company commander, with the approval of the adjutant general, may employ an armorer to assist in the proper care of military property for which he is accountable.*

Section 649—19a. There shall be paid annually to each band of the Wisconsin National Guard for armory rent the sum of two hundred dollars, and to troop "A" First Cavalry and First Battery Field Artillery each an additional one thousand dollars annually for the purchase, care and feed of horses, *and to the hospital corps three hundred fifty dollars annually for armory rent.*

SECTION 2. This act shall take effect and be in force from and after its passage and publication.
