CHAPTER 44.

AN ACT to amend subsection 1 of section 1727m of the statutes, relating to individual towels.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1 of section 1727m of the statutes is amended to read: (Section 1727m.) 1. All towels for the use of guests in any hotel, whether in their private rooms or the public wash room, and all towels in * * * *such places or buildings, whether publicly or privately owned, as the state board of public health may find the use of the common towel therein to be inimical to the public health, * * * shall be individual towels and when used and discarded by the individual, * * * shall not be again used until thoroughly washed and dried.*

CHAPTER 45.

AN ACT to authorize the city of Eau Claire to build a bridge across the Chippewa river.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The city of Eau Claire, in the county of Eau Claire, and state of Wisconsin, is hereby enabled, permitted, authorized and empowered to erect and forever maintain a bridge across the Chippewa river, between a suitable point to be selected by the council of said city, on government lot eleven, in the southwest quarter of section twenty, in township twenty-seven north, of range nine west, on the westerly side of said river, and some suitable point on government lot one, in the southeast quarter of said section, on the easterly side of said river; and

for such purpose may erect piers, drive piles, build embankments and approaches in said river and on the banks thereof, suitable and necessary for the proper construction and maintenance of said bridge, and enjoy all the rights hereby granted or intended to be granted.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 46.

AN ACT to amend subdivision (b) of subsection 1, of section 4562d of the statutes, relating to the hunting of deer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subdivision (b) of subsection 1 of section 4562d of the statutes is amended to read: (Section 4562d) 1. (b) Any deer in the counties of Grant, LaFayette, Green, Rock, Walworth, Kenosha, Racine, Milwaukee, Waukesha, Jefferson, Dane, Iowa, Crawford, Richland, Sauk, Columbia, Dodge, Buffalo, Washington, Ozaukee, Sheboygan, Fond du Lac, Green Lake, Pepin, Marquette, Adams, Vernon, Monroe, La Crosse, Wau-shara, Winnebago, Calumet, Manitowoc, Outagamie, Brown, Door, Kewaunee, Portage and Waupaca at any time; and in the county of Wood until November tenth, 1916.

SECTION 2. This act shall take effect and be in force from and after its passage and publication.

CHAPTER 47.

AN ACT to appropriate to James Larsen, member of assembly from Marinette county, a certain sum of money as salary and mileage.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is hereby appropriated out of any moneys in the treasury not otherwise appropriated the sum of five hundred forty-nine dollars and twenty cents to James Larsen, of Marinette, Wisconsin, as his salary and mileage as member of the assembly for the years 1913 and 1914.
