**CHAPTER 415.**

AN ACT to repeal subdivision (10) of section 926—11 of the statutes, and to create a new subdivision to be numbered (10) of section 926—11 of the statutes, relating to the power of cities operating under special charters, to issue bonds for street improvements.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subdivision (10) of section 926—11 of the statutes, is repealed.

SECTION 2. There is added to section 926—11 of the statutes, a new subdivision to be numbered and to read: (Section 926—11) (10). For permanently improving streets in such city, and for creating either a revolving or a temporary fund out of which to advance the cost of paving streets and building and repairing sewers and sidewalks, in anticipation of the collection by the city treasurer of the special assessments, special improvement certificates and improvement bonds, made or issued for the cost thereof.

SECTION 3. This act shall take effect upon passage and publication.

**CHAPTER 416.**

AN ACT to create section 959—115 of the statutes, relating to the powers of cities of the fourth class with respect to penalties.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. There is added to the statutes a new section to read: Section 959—115. The common council of any city of the fourth class, however organized, shall have power, by ordinance, resolution, by-law, or regulation to compel any person committed to the watch house or place of confinement of such city who is not physically disabled, to perform labor upon any public work of such city under such supervision and control as such city may provide, and for each day's labor performed, said person so sentenced shall be credited with the sum of two dollars, which shall apply on such fine and costs until the same are paid or until such person is released from custody.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 417.

AN ACT to amend section 417 of the statutes relating to the name of school districts.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 417 of the statutes is amended to read: Section 417. The word district as used in this chapter, unless otherwise defined, means school district, and a district lawfully organized is a body corporate and possesses the usual powers of a public corporation by the name and style of school district (joint) school district number . . . ., of the town (towns) of . . . ., name of the town (towns) in which the district is situated. Such number shall be designated by the town board or boards in the order \* \* \* of the formation thereof. The board shall make its contracts in its corporate name. *Provided, however, that when the territory embraced in any district or districts shall have been heretofore or shall hereafter be organized into a village or city, such district shall be known by the same name as theretofore but with the name of such village or city substituted in lieu of the name of such town, and the use heretofore of the name of such village or city in lieu of the name of such town in the designation of such a school district is hereby legalized and confirmed.*

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 418.

AN ACT to amend section 1321a of the statutes, relating to bridges across navigable and meandered streams.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 1321a of the statutes is amended to read: Section 1321a. 1. \* \* \* Any city, \* \* \* village or town \* \* \* bordering upon or through which any navigable or meandered stream runs. \* \* \* is authorized and empowered *either alone or jointly* to build, purchase or main-
