CHAPTER 527.

AN ACT to refund a sum of money therein specified to Dane county on account of said county having erroneously paid such amount to the state treasurer.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated to the county treasurer of Dane county out of any money in the general fund not otherwise appropriated, the sum of thirteen and seventy-two one-hundredths dollars, said sum having been erroneously paid into the state treasury by the treasurer of Dane county.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 528.

AN ACT appropriating a sum of money therein named to Michael Kleist.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated forty dollars, payable from any moneys in the general fund not otherwise appropriated, to Michael Kleist to reimburse him for expenses incurred in defending an action brought against him as game warden in which action he was discharged.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 529.

AN ACT making appropriations therein named to satisfy claims arising out of the slaughter of tubercular cattle.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. There is appropriated one hundred fourteen dollars and thirty-seven cents to H. Beeten, of the town of Sharon in Walworth county, and there is appropriated forty-nine dollars and thirty-seven cents to Wilbur M. Rundell of the town of

Livingston in Grant county, payable from any moneys in the general fund not otherwise appropriated, said sums to be in full payment of the claims of said H. Beeten and said Wilbur M. Rundell against the state, which claims arise out of the slaughter of tubercular cattle, ordered slaughtered by the state veterinarian and condemned under proceedings conducted by police justices in the years 1914 and 1915, in Walworth and Grant counties.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 530.

AN ACT to amend section 425 of the statutes, relating to the date for the annual school district meeting.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 425 of the statutes is amended to read: SECTION 425. The annual district meeting in all school districts shall be held on the first Monday of July, unless that be a legal holiday, in which case it shall be held on the next day at eight o'clock in the afternoon, and any annual meeting heretofore or hereafter held shall be valid notwithstanding any provision to the contrary in any special or local law. Provided, that that part of this section fixing the date *and time* of the annual school district meeting shall not become effective until the third day of January, 1916. Any special meeting of any school district shall be held on the day called for at eight o'clock in the afternoon. It shall be the duty of the district board to meet on the Saturday immediately preceding the annual meeting, carefully examine the accounts of the treasurer, and make up a full and itemized report of all receipts and expenditures since the last annual meeting, of the amount in the hands of the treasurer or the amount of the deficit for which the district is liable, of the amount necessary to be raised by taxes for the support of the school for the ensuing year, and of the amount required to pay the interest or principal of any debt due or to become due during such year; which report shall be submitted in writing at the annual meeting and recorded by the clerk at length with the action thereon in the proceedings of the meeting.

SECTION 2. All school district meetings held during the year 1915 in accordance with and pursuant to law in all respects,
