

priated, for the state * * * *department* of agriculture, the following sums of money for the purposes stated:

(a) * * * *Forty-five* thousand dollars to be available upon the filing of the certificate provided for in subdivision (e) for * * * *construction of swine and sheep barns and judging pavilions*, and ten thousand dollars, to be available upon the passage and publication of this act, for repair and construction of fences and the enclosure of open structures.

(b) * * * *Fifty* thousand dollars for construction of a grandstand to be available July 1, 1916.

(c) *Twenty-five* thousand dollars for construction of a poultry building * * * and * * * *twenty-five* thousand dollars for * * * *sanitation and sewage* to be available July 1, 1917.

(d) *Fifty* thousand dollars for the construction of a grandstand to be available July 1, 1918.

(e) *Fifty* thousand dollars for the construction of a grandstand to be available July 1, 1919.

Provided, that no part of this appropriation *excepting the appropriation in subdivision (a) for repair and construction of fences and the enclosure of open structures* shall be paid out of the state treasury until and unless the state * * * *department of agriculture* certifies in writing to the secretary of state and to the state treasurer that Milwaukee county has conveyed, granted or donated in a manner authorized by subdivision (9t) of section 669, to the state of Wisconsin, lands, which in the judgment of the * * * *department* are sufficient in amount, suitable in location and otherwise satisfactory for state fair purposes and that the deed or deeds of conveyance of such lands have been approved by the attorney-general.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 568.

AN ACT to amend subsection 4, to repeal subsection 5 and to create subsection 5 of section 172—49 of the statutes, making appropriations for Stout institute.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 4 of section 172—49 of the statutes is amended to read: (Section 172—49.) 4. There is annually

appropriated * * * *beginning* July * * * 1, 1915, * * * *thirty* thousand dollars, payable from any moneys in the general fund not otherwise appropriated, for Stout institute for current expenses. Any unexpended balance shall be available in subsequent years.

SECTION 2. Subsection 5 of section 172—49 of the statutes is repealed.

SECTION 3. There is added to section 172—49 of the statutes, a new subsection to be numbered and to read: (Section 172—49.) 5. There is appropriated on July 1, 1915, twenty-five thousand dollars and on March 1, 1916, twenty-five thousand dollars, payable from any moneys in the general fund not otherwise appropriated, for Stout institute for the equipping and furnishing of buildings and for other permanent improvements at the said institute.

SECTION 4. This act shall take effect as of July 1, 1915.

CHAPTER 569.

AN ACT to amend subsection 1 of section 2464 of the statutes, relating to the holding of special terms of county court in certain counties.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection 1 of section 2464 of the statutes is amended to read: (Section 2464) 1. The county judges of the counties of Chippewa, Columbia, Dodge, Fond du Lac, Grant, Green Lake, Jefferson, Monroe, Pepin, *Pierce*, Shawano, Trempealeau, Walworth, Washington and Waukesha may keep their offices and hold special terms of the county court at any time between the times of holding the regular terms and transact any business which might be done at, or which may be continued from, any regular term to such special term at the following places, in their respective counties:

In the county of Chippewa, at the cities of Chippewa Falls and Stanley;

In the county of Columbia, at the city of Columbus;

In the county of Dodge, at the cities of Beaver Dam, Mayville and Watertown;

In the county of Fond du Lac, at the cities of Ripon, and Waupun;
