

Section 513. Women of the age of twenty-one or more years who reside and for one year next prior to their election or appointment have resided in any school district, town, city, or county, are eligible by election or appointment to the offices of director, treasurer and clerk of such district, \* \* \* member of the school board or board of education of such city, town inspector of schools of such town and county superintendent of such county.

SECTION 2. This act shall take effect upon passage and publication.

## CHAPTER 621.

AN ACT to amend sections 137 and 172—2 of the statutes and to repeal Chapter 456, Laws of 1885, relating to the biennial reports of state officers; making an appropriation for the executive department; and repealing the appropriation for the state claim agent.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Sections 137 and 172—2 of the statutes are amended to read: Section 137. The governor shall communicate to the legislature at the commencement of each biennial session thereof the reports of all the state officers and boards of officers required by law to report to him, and the reports of the state officers whose term of office has expired, of the transactions in their respective offices from the thirtieth day of \* \* \* June in the last year of their term. He shall also at the same time render a statement of all expenditures made by him out of any contingent fund appropriated by the legislature for the contingent expenses of the executive office.

Section 172—2. 1. There is \* \* \* appropriated, \* \* \* July 1, \* \* \* 1915, \* \* \* and each second year thereafter, sixteen thousand one hundred ten dollars and on July 1, 1916, and each second year thereafter, eighteen thousand one hundred ten dollars, payable from any moneys in the general fund not otherwise appropriated, for the executive department to carry into effect the powers, duties and functions provided by law for said department. *An unexpended balance at the end of any fiscal year shall be available thereafter.*

2. There is annually appropriated, beginning July 1, 1913, two thousand dollars, payable from any moneys in the general fund not otherwise appropriated, as a contingent appropriation

for the executive department to carry into effect the powers, duties and functions provided by law for said department.

SECTION 2. Chapters 456, laws of 1885, is repealed.

SECTION 3. This act shall take effect as of July 1, 1915.

## CHAPTER 622.

AN ACT to accept and annex certain territory heretofore constituting a part of the town of La Crescent, in the county of Houston and state of Minnesota, to Wisconsin and to make said territory a part of the county La Crosse, and to cede to the state of Minnesota a certain portion of the town of Buffalo, in the county of Buffalo.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Sovereignty and jurisdiction over all that territory heretofore constituting a part of the town of La Crescent, county of Houston and state of Minnesota, which lies easterly of the following described line, to wit:

Commencing in the northeast quarter of section number eleven, township number one hundred four north, range number four west, at the point of intersection of the center lines of the west channel of the Mississippi river with the center line of the main east channel of said river, and running thence southeasterly along the center line of said west channel to its intersection with the center line of said main east channel of said river, in the easterly part of section number twenty-four, in said township and range, being the territory described in, and ceded to the state of Wisconsin by an act of the legislature of the state of Minnesota entitled "An act to cede a portion of the town of La Crescent in the county of Houston, and state of Minnesota, consisting of island lands in the Mississippi river, to the state of Wisconsin," approved April 23, 1913, and known as chapter 437 of the laws of Minnesota for the year 1913, and the cession of the same to the state of Wisconsin, are hereby accepted, in part, by the state of Wisconsin, that is, upon the terms and conditions that the state of Wisconsin cede to the state of Minnesota certain territory in the county of Buffalo, state of Wisconsin, as provided in this act. Said territory heretofore constituting a part of the town of La Crescent in the county of Houston and state of Minnesota, above described, shall upon the taking effect of this
