CHAPTER 632

AN ACT to amend subsection (1) of section 20.05 of the statutes, relating to the state treasurer, and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 20.05 of the statutes is amended to read:

(20.05) (1) Annually, beginning July 1, * * * 1917, * * * *twenty-six thousand four hundred* dollars for the execution of his functions. Of this there is allotted:

(a) To the state treasurer an annual salary of five thousand dollars.

(b) To the assistant state treasurer an annual salary of two thousand five hundred dollars.

SECTION 2. Any unexpended balance remaining in the appropriation made by subsection (1) of section 20.05 on July 1, 1917, shall revert to the general fund.

SECTION 3. This act shall take effect upon July 1, 1917.

CHAPTER 633

AN ACT to repeal paragraph (1) of subsection 2 of Section 1728a—3; and to create a new paragraph of subsection 2 of Section 1728a—3 of the statutes, relating to child labor.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (1) of subsection 2 of section 1728a—3 of the statutes is repealed.

SECTION 2. A new paragraph is added to subsection 2 of section 1728a—3 of the statutes to read:

(Section 1728a—3.2) (1) Such evidence as is required by the industrial commission showing that such child is at least fourteen years of age. The industrial commission shall formulate and publish rules and regulations governing the proof

of age of minors who apply for labor permits, and such rules and regulations shall be binding upon all persons authorized by law to issue such permits.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 634

AN ACT to amend title III of the statutes of 1915, to renumber chapter 12a thereof relating to the legislature, and to renumber and revise the sections of said chapter.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Title III of the statutes of 1915 is amended to read:

TITLE III.

GENERAL ORGANIZATION OF THE STATE, EXCEPT THE JUDICIAL DEPARTMENT.

SECTION 2. Chapter 12a of the statutes of 1915 is renumbered to be chapter 13.

SECTION 3. A new section is added to the statutes to read: 13.01 NUMBER OF LEGISLATORS. The senate consists of thirty-three and the assembly of one hundred members.

SECTION 4. Section 99 of the statutes is renumbered and amended to read: 13.02 REGULAR SESSIONS. The regular session of the legislature shall commence at twelve o'clock M. on the second Wednesday of January * * * in each odd-numbered year.

SECTION 5. Section 100 of the statutes is renumbered and amended to read: 13.03 OATHS OF MEMBERS. The speaker of the assembly, * * * president of the senate, the governor, secretary of state, attorney-general or any justice of the supreme court * * * may administer the oath of office to the members and officers of the legislature; * * *

SECTION 6. Section 110 of the statutes is renumbered and revised to read: 13.04 COMPENSATION CERTIFICATE. The presiding officer of each house, immediately after the commencement of each regular or extra session of the legislature, shall certify to the secretary of state the names of all qualified members of the house over which he presides; also the number of miles of travel for which each member is entitled to compensa-
