## CHAPTER 265.

AN ACT to amend subsection (33) of section 1038 of the statutes, relating to exemptions from taxation.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (33) of section 1038 of the statutes is amended to read: (Section 1038) (33) All the real and personal property of any orphan asylum or orphans' home located in the state so long as the same is actually used for such home.

Section 2. This act shall take effect upon passage and publication.

## CHAPTER 266.

AN ACT to detach certain territory from the town of Radisson, Sawyer county, to create the town of Ojibwa and to provide for an apportionment of assets and liabilities between said towns.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. The territory described as follows: the south half of township thirty-nine north, range six west, and the north half of township thirty-eight, range six west, is detached from the town of Radisson, Sawyer county, and such territory is created and constituted a separate town to be known as the town of Ojibwa in said county.

SECTION 2. The territory described as follows: the north half of township thirty-nine north, range six west is detached from said town of Radisson and is attached to and constituted a part of the town of Hunter in said county.

Section 3. The first town meeting of said town of Ojibwa, shall be held at the Raynor farm house in section four, in township thirty-eight north, range six west, on Tuesday, July 1, 1919, and shall by ballot elect town officers, and exercise all other powers and make such provisions for the town government as are now authorized by statute to be exercised and made at the town meeting of any town. For the purpose of said election the qualified electors of the said town of Ojibwa, assembled at the place aforesaid, shall, between the hours of nine and twelve o'clock in the forenoon of said day, choose three of their number

to act as inspectors of said election, and such inspectors shall, before entering upon their respective duties, severally take the usual oath of office and file the same with their returns; and such inspectors shall respectively canvass and return the votes cast at such election in all respects as provided by law for inspectors at annual town meeting. A town clerk and also necessary clerks of election shall be appointed by said inspectors, or a majority thereof, to assist said inspectors in conducting said town meeting and in canvassing and returning the votes cast at such election.

Section 4. Notice of said town meeting shall be given by the posting of a copy of this act in at least six public places in said town of Ojibwa at least five days before the time of holding said first town meeting by any duly qualified elector of said town who shall make a proper affidavit of such posting and file the same on the day of said first town meeting with the inspectors chosen to conduct said first town meeting.

SECTION 5. When said town meeting shall have been held as herein provided, and the town officers as required by law duly elected, the said town of Ojibwa shall be deemed to be and shall be duly organized, and shall possess all the rights, powers, privileges and authority, and shall be subjected to the usual liabilities of other towns in the state of Wisconsin.

SECTION 6. When the town of Ojibwa is duly organized as provided in this act the property and assets and the liabilities of the town of Radisson shall be apportioned as follows:

- (1) The said town of Radisson shall pay to the town of Ojibwa the sum of five hundred dollars in full settlement of all claims which the said town of Ojibwa and the town of Hunter may have to any property or assets of the town of Radisson.
- (2) The said towns of Ojibwa and Radisson shall jointly construct the highway now laid out and proposed to be built on the center line east and west of township thirty-eight north, range six west and for the construction of which the county of Sawyer has appropriated two thousand dollars; and the cost of constructing such highway in excess of the two thousand dollars appropriated by said county of Sawyer shall be paid equally by said towns.

Section 7. This act shall take effect upon passage and publication.
