- (3) All such officers shall be subject, furthermore, to service with the troops of the national guard of the state at such time and place as the governor or the adjutant general may direct, but not to receive pay unless so serving.
- (4) The governor shall annually appoint a committee of three members, one of whom shall be appointed on the recommendation of the adjutant general, one on the recommendation of the state superintendent of public instruction and one on the recommendation of the president of the state board of health. With a view to the proficiency of the said departments, said committee shall, without any notice whatsoever, visit and inspect the post, making a thorough inspection of the military and naval department, the discipline, the course of study and work of the academic department, and the sanitary condition of the post, and report to the governor the results of such inspections.
- (5) The graduates of the courses in military science and tactics in any such university, college, or academy as may be designated a post of the national guard and be under inspection as directed, shall be eligible to appointment as second lieutenants in the Wisconsin national guard, and may be commissioned as such, and assigned to vacancies at the discretion of the governor upon the recommendation of the commanding officer of the post. provided such graduates are residents of the state of Wisconsin.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 303.

AN ACT to repeal subsection (3) of section 23.11 of the statutes, relating to the procedure in condemnations of land by the conservation commission; to renumber and amend section 1494—40 of the statutes, relating to the conservation of natural resources; and to amend section 35.32 of the statutes, relating to the public printing.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Subsection (3) of section 23.11 of the statutes is repealed. •

Section 2. Section 1494—40 of the statutes is renumbered to be subsection (3) of section 23.11 and is amended to read:

(23.11) (3) * * Said commission * * shall consider the natural resources of the state * * and report to the governor * * from time to time the results of its in-

vestigations with recommendations * * of such measures * as it deems necessary or suitable to conserve * such resources and preserve them, so far as practicable, unimpaired. * *

Section 3. Section 35.32 of the statutes is amended by inserting therein immediately after the last semicolon and immediately before the words "also such books" the following words, namely: "of any report made by the conservation commission under subsection (3) of section 23.11, so many copies as may be ordered by the governor;".

SECTION 4. This act shall take effect upon passage and publication.

CHAPTER 304.

AN ACT to create subsections 1a and 2a of section 1492ab—2 of the statutes, relating to creameries and cheese factories.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

Section 1. Two new subsections are added to section 1492ab—2 of the statutes to read: (Section 1492ab—2) 1a The provisions of subsection 1 shall not apply to any cheese factory or creamery all milk delivered to which comes from cows which have successfully passed an examination for tuberculosis within one year. Such examination shall be made by a duly licensed veterinarian.

(Section 1492ab—2) 2a. Whenever a majority of the patrons of any cooperative cheese factory or creamery, at any regularly called meeting of such cooperative association, shall vote to have their cows tested as provided in subsection 1a, no milk shall thereafter be accepted at any such factory or creamery, except from cows which have successfully passed such test.

Section 2. This act shall take effect upon passage and publication.
