## CHAPTER 334.

AN ACT to create the fifth paragraph of section 2619 and to renumber paragraphs fifth, sixth, seventh, eighth and ninth of section 2619 to be paragraphs sixth, seventh, eighth, ninth and tenth, respectively, relating to place of trial of civil actions.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new paragraph is added to section 2619 of the statutes to read: (Section 2619) Fifth. Of an action against an insurance company, existing under the laws of this state to recover on a policy of insurance the county in which the defendant has its principal office, or, at the election of the plaintiff, if a resident of this state, the county in which the plaintiff resides or if the action is brought by a person in a representative capacity by appointment of a court of this state, the county in which the proceedings resulting in such appointment was had.

SECTION 2. Paragraphs fifth, sixth, seventh, eighth and ninth of section 2619 of the statutes are renumbered to be paragraphs sixth, seventh, eighth, ninth and tenth, respectively.

SECTION 3. This act shall take effect upon passage and publication.

## CHAPTER 335.

AN ACT to create section 1770f of the statutes, to prevent collection upon subscriptions for stock or other stock liability by foreign corporations.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to read: Section 1770f. No corporation organized under the laws of any other state or territory or of any foreign country required to file its articles and otherwise comply with the terms of section 1770b, and no receiver, assignee, trustee or officer thereof, however appointed, shall maintain any action in any of the courts of this state upon any subscription for stock or stock liability or assessment, however imposed, against any citizen or resident of the state of Wisconsin, if such subscription was made or the stock sold or delivered within this state, and such corporation had not, at the time of taking such subscription

or selling said stock, complied with the provisions of said section 1770b and received a license to transact business in this state. This section shall not apply where the person subscribing for or purchasing the stock shall have received dividends thereon or shall have acted as an officer of the corporation, and shall not apply to actions pending in any court of this state on April 22, 1919.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 336.

AN ACT to create section 10.25m of the statutes, relating to return and destruction of ballots at primary and city elections in cities having more than one hundred thousand inhabitants.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new section is added to the statutes to read: 10.25m In any city having a population of one hundred thousand or more, the provisions of section 6.60 as the same relates to the return and destruction of ballots shall apply to local primaries and elections so far as applicable; provided, however, that the election commission mentioned in section 10.01 shall have custody of such ballots and destroy them within the time and in the manner as provided in section 6.60.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 337.

AN ACT to amend paragraph "ninth circuit" of section 113.06 of the statutes, relating to the time of holding terms of court in the ninth judicial circuit.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Paragraph "ninth circuit" of section 113.06 of the statutes is amended to read: (113.06) (Ninth circuit) In the county of Dane on the second Monday in January, the \* \* \* *second Monday in March* and the second Monday in September; in the county of Sauk on the first Monday in March, and the second Monday in September.
