CHAPTER 664.

AN ACT to amend subsection (1) of section 20.51, and to create subsection (3) of section 20.51, relating to the railroad commission, and making appropriations.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 20.51 is amended to read: (20.51) (1) * * * *Annually*, beginning July 1, * * * 1919, one hundred * * * *eighty-five* thousand dollars, for administration and the execution of its general functions. Of this there is allotted to each member of said commission an annual salary of five thousand dollars.

SECTION 2. There is added to section 20.51 of the statutes a new subsection to be numbered and to read: (20.51) (3) On July 1, 1919, not to exceed fifteen thousand dollars, for expenses incurred in printing the Wisconsin railroad map, including the cost of the stone.

SECTION 3. This act shall take effect July 1, 1919.

CHAPTER 665.

AN ACT to amend paragraph (e) of subsection (3) of section 40.74 of the statutes, relating to records and reports by teachers in public, private and parochial schools.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (e) of subsection (3) of section 40.74 of the statutes is amended to read: (40.74) (3) (e) All teachers of private and parochial schools shall keep a record embodying all the data enumerated in this section, and such record shall be open to the inspection of all truant officers specified in this act, at any and all reasonable times; and provided that when called upon by any truant officer, * * * the teachers in private or parochial schools * * * shall furnish in writing on blanks furnished by the truant officer * * * the above-mentioned data in regard to any child or children between the ages of seven and fourteen and fourteen and sixteen who claim or who are claimed to be in attendance upon said school; and every teacher in a public, * * * private or parochial school * * * shall promptly notify the proper truant officer

of any child whose attendance is habitually irregular; provided such irregularity is not excused by any provision of this act.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 666.

AN ACT to amend section 4423a of the statutes, relating to the unauthorized wearing or use of the insignia, rosette, or badge of any society, order or organization, operating under the lodge system and prescribing a penalty.

The people of the state of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Section 4423a of the statutes is amended to read: Section 4423a. Any person who shall wilfully wear the insignia, * * * rosette, or badge or any imitation thereof, of the military order of the Loyal Legion of the United States, * * * the Grand Army of the Republic, * * * the United Spanish War Veterans, or * * * the military order of Foreign Wars, or of the Benevolent and Protective Order of Elks of the United States, Knights of Columbus, Odd Fellows, Free Masons, Knights of Pythias, or of any other society, order, or organization, operating under the lodge system, of ten years standing in the State of Wisconsin, or shall wilfully use the same to obtain aid or assistance thereby within this state, or shall wilfully use the name of such society, order or organization, the titles of its officers, or its insignia, unless he shall be entitled to use or wear the same under the constitution, by-laws, rules and regulations * * * thereof, shall be punished by imprisonment in the county jail not more than thirty days or by a fine not exceeding twenty dollars, or by both such fine and imprisonment.

SECTION 2. This act shall take effect upon passage and publication.
