**CHAPTER 108.**

AN ACT to renumber section 193.01 of the statutes to be subsection (1) of said section, and to create subsection (2) thereof, relating to franchises to street railway corporations for the use of the space under and above public streets.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 193.01 is renumbered to be subsection (1) of section 193.01 of the statutes.

SECTION 2. A new subsection is added to section 193.01 of the statutes to read: (193.01) (2) Whenever any city shall determine that the accommodation of public travel requires the use of space beneath or over the surface of any street, alley or public ground it may authorize, subject to the provisions of sections 193.33 to 193.45 of the statutes, any street or interurban railway corporation on such terms as may be agreed upon to construct and maintain, for the operation of its cars and trains thereon or therein, elevated structures crossing or proceeding above and subways crossing or proceeding beneath the surface of any street, alley or public ground, including approaches, entrances, sidings, stations and connections. Any city may provide any such elevated or subway structure and may authorize the use thereof by a street or interurban railway corporation on such terms as may be agreed upon.

SECTION 3. This act shall take effect upon passage and publication.

**CHAPTER 109.**

AN ACT to amend subsection (3) of section 60.29 of the statutes, relating to the powers of town boards.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Subsection (3) of section 60.29 of the statutes is amended to read: (60.29) (3) To procure legal advice when

needed in the conduct of town affairs and employ counsel for that purpose; *also such stenographic, clerical and expert help as may from time to time be necessary.*

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 110.

AN ACT to create subsection (6) of section 187.01 of the statutes, relating to religious societies changing names.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. A new subsection is added to section 187.01 of the statutes to read: (187.01) (6) The name of such corporation may be changed at any annual or special meeting, by a majority vote of the members present. Notice that the matter of changing its name will be voted upon at such meeting shall be given as is provided by subsection (4) for its first meeting and the same persons may vote thereon.

SECTION 2. This act shall take effect upon passage and publication.

### CHAPTER 111.

AN ACT to amend section 69.50 of the statutes, relating to reports of divorcees.

*The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:*

SECTION 1. Section 69.50 of the statutes is amended to read: 69.50 The clerk of every court having jurisdiction of divorce proceedings shall, \* \* \* *within thirty days after January first* of each year, return to the state registrar of vital statistics upon the blanks provided for that purpose, statistics relative to each
