CHAPTER 94.

AN ACT to amend paragraph (a) of subsection (26) of section 20.17 and subsection (3) of section 50.07 of the statutes, relating to county sanatoria and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (a) of subsection (26) of section 20.17 and subsection (3) of section 50.07 of the statutes are amended to read: (20.17) (26) (a) From time to time such sums as may be necessary, to be credited and charged on taxes, as provided in sections 46.10, 50.07, 51.08, 51.12, 51.26, 51.27 and 51.28 of the statutes.

(50.07) (3) Each county maintaining *in whole or in part* such an institution shall be credited by the state, to be adjusted as provided in section 46.10, for each patient cared for therein at public charge, as follows:

(a) For each such patient whose support is chargeable against said county, * * * *seven dollars per week.*

(b) For each such patient whose support is chargeable against some other county, the total cost of his maintenance as determined by the board of trustees of the institution and the state board of control; and the state shall charge over to such other county the difference between such total cost and * * * *seven dollars per week provided through state aid.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 95.

AN ACT to amend subsection (1) of section 47.08 of the statutes, relating to pensions for blind and deaf.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (1) of section 47.08 of the statutes is amended to read: (47.08) (1) Any male person over the

age of eighteen, and any female person over the age of eighteen years, who is declared to be blind or blind and deaf as hereinafter provided shall receive from the county of which he or she is a resident an annual pension payable quarterly. Such pension shall be an amount which, when added to any amount received as an income from other sources, shall not * * * exceed * * * *seven* hundred and eighty dollars * * *. In no event, however, shall any pension exceed three hundred and sixty dollars if *the person receiving the pension is* blind and four hundred and eighty dollars if both blind and deaf.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 96.

AN ACT to amend paragraph (c) of subsection (7) of section 20.17 of the statutes, relating to the institute for blind artisans and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Paragraph (c) of subsection (7) of section 20.17 of the statutes is amended to read as follows: (20.17) (7) (c) On July 1, 1925, ten thousand dollars, together with any materials then in stock, pursuant to the provisions of this subsection, to be invested in materials, payment of artisans, and for expenses incident to manufacture * * * *of different articles*; and whenever any such materials, or the articles manufactured therefrom, are sold, the proceeds thereof shall be paid into the general fund within one week of receipt, and credited back to this appropriation.

SECTION 2. This act shall take effect upon passage and publication.
