CHAPTER 373.

AN ACT to create sections 20.675 and 253.31 of the statutes, relating to uniform forms in county courts and making an appropriation.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 20.675 There is hereby appropriated out of the general fund to the board of county judges five hundred dollars to defray the expenses of preparing the uniform forms provided for in section 253.31.

SECTION 2. A new section is added to the statutes to read: (253.31) (1) The board of county judges or its duly authorized committee shall from time to time adopt such uniform forms for use in the administration of the judicial business of the county courts as they deem necessary.

(2) Duly authenticated copies of all legal forms so adopted shall be furnished the office of secretary of state and there be kept on file and copies thereof shall, by the secretary of state, be transmitted to all of the county courts of Wisconsin.

(3) Only such applications and other process when properly presented to the county court on such uniform forms shall in the discretion of the court be received and accepted by every such court on and after January 1, 1931.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 374.

AN ACT to amend subsection (5) of section 70.26 of the statutes, relating to the platting of lands for assessment purposes.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. Subsection (5) of section 70.26 of the statutes is amended to read: (70.26) (5) In counties having a population of two hundred and fifty thousand or more, the powers and

duties herein provided, except as to the publication of notice, shall be exercised by the county board upon request of the town or village board or boards affected, *without limitation as to the area of land which may be included in any plat*; provided, that the cost and expenses of such plats shall be paid by the county. *In any plat made subject to the provisions of this subsection, the placing of stones or stakes as required by section 236.16 of the statutes may be omitted.*

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 375.

AN ACT to create section 62.195 of the statutes, relating to the assessment of cost of street improvement in certain cities.

The people of the State of Wisconsin, represented in Senate and Assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 62.195 In counties having a population of two hundred fifty thousand or more, in addition to other methods provided by law, the council of any city of the second, third or fourth class may by ordinance provide that the cost of installing, constructing or laying storm sewers, sanitary sewers, water mains, paving or any other public improvement to be installed along or in any street or highway in such city shall be charged in whole or in part to the property benefited thereby, and to make an assessment against such property in such manner as such council may determine.

SECTION 2. This act shall take effect upon passage and publication.
