

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 343.655 Any person who shall sell forestry stock furnished by the conservation commission for reforestation purposes shall be deemed guilty of a misdemeanor, and upon conviction thereof shall be punished by a fine of not less than fifty dollars nor more than two hundred dollars.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 163.

AN ACT to create section 29.475, relating to the removal of the furs and other parts of the carcasses of protected wild animals, birds or fish from Indian reservations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to be numbered and to read: 29.475 No person shall remove or take from any Indian reservation the carcass of any protected wild animal, bird or fish or any part thereof, including the fur, during the close season for such animal, bird or fish without a permit from the state conservation commission issued under such regulations as it may prescribe.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 164.

AN ACT to amend subdivision 4 of section 23 of chapter 218 of the laws of 1923, relating to the county court of Wood county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subdivision 4 of section 23 of chapter 218 of the laws of 1923 is amended to read: (Chapter 218, laws of 1923)

(Section 23) 4. Said reporter and assistant reporter shall furnish parties to an action, or their attorneys, requiring them, transcripts of the testimony and proceedings had at a price not to exceed * * * *eight cents per folio*; and * * * *four cents per folio* for copies. Until otherwise fixed by the county board, the per diem compensation of said reporter and assistant reporter shall be paid out of the treasury of the county of Wood upon the order of the judge.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 165.

AN ACT to create section 348.49 of the statutes, relating to extortion by detectives, and imposing penalties.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. A new section is added to the statutes to read: 348.49 Any employer and any person employed to detect dishonesty on the part of employes, or fiduciary agents, on a commission basis or under a contract calling for a percentage of the amount recovered through or by reason of the detective work done by such person, shall submit the facts of the case and the settlement made with such employe or fiduciary agent to the circuit judge of the county wherein the dishonest act was committed, for approval or further proceedings, and the employe shall be notified of such hearing and shall have a right to be heard. Any such person or employer who shall not so submit the facts and settlement as made to such circuit judge for approval or further proceedings, shall be deemed guilty of a misdemeanor, and upon conviction shall be fined not less than one hundred dollars nor more than five hundred dollars, or imprisoned in the county jail not less than three months nor more than one year.

SECTION 2. This act shall take effect upon passage and publication.
