CHAPTER 276.

AN ACT to repeal section 352.40 of the statutes, relating to whey butter.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 352.40 of the statutes is repealed.

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 277.

AN ACT to amend section 29.191, and paragraphs (l), (qa), and (u) of subsection (1) and subsection (2) of section 29.28, and to create paragraph (aa) of subsection (1) and subsection (4) of section 29.28 of the statutes, relating to ice fishing.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 29.191, and paragraphs (l), (qa), and (u) of subsection (1) and subsection (2) of section 29.28 of the statutes are amended to read: 29.191 There shall be no close season for hook and line fishing, except for large and small-mouthed bass, sturgeon and trout, in any of the following described waters: In the waters of the Mississippi river, * * * the bays and bayous connected therewith and in the waters of Lafayette, Iowa and Green counties; in the waters of Lake Winnebago in Fond du Lac, Calumet and Winnebago counties; in Buffalo lake, Marquette county; in Puckaway lake in Marquette and Green Lake counties; in Lake Poygan in Winnebago and Waushara counties; in Lakes Winneconne, Big and Little Butte des Morts in Winnebago county; in the Fox river in Marquette, Columbia, Green Lake, Waushara and Winnebago counties; in the Wolf river in Winnebago and Waupaca counties; * * * in the Rock and Crawfish rivers and in Lake Ripley and Lake Koshkonong in Rock, Jefferson and Dodge counties. During the period from March first to May twenty-eighth, both dates inclusive, live or dead minnows shall not be used for bait in any of the above waters specified in Jef-

erson county. There shall be no close season for hook and line fishing in Lake Wisconsin in Columbia and Sauk counties for perch, bluegills, sunfish, crappies and bullheads. *There shall be no close season for fishing through the ice with hook and line for fish of any variety in the waters of the Mississippi river, and the lakes, bays, bayous and sloughs tributary thereto and connected therewith, except in Lower Lake St. Croix and up the St. Croix river to the Dells, in the counties bordering on the Mississippi river, or in the waters of Allouez bay, Superior bay, St. Louis bay and St. Louis river connected with Lake Superior; the quantity and minimum length of fish so taken shall be as prescribed in section 29.19, and such fish shall not be sold or bartered.* In Kenosha county the open season for the varieties of fish described in subsections (6) and (7) of section 29.19 shall commence on May twenty-ninth.

(29.28) (1) (1) Oneida county: * * * Sugar Camp chain of lakes, Stone lake, Swamp lake, Silver lake, Dam lake, Sand lake, Echo lake or Chain lake, all of the last mentioned lakes being located in town thirty-eight north, range nine east and town thirty-nine north, range eight east; Post lake in Langlade and Oneida counties; *Big Rice lake and flowage and Little Rice lake and flowage in Oneida and Lincoln counties.*

(qa) Trempealeau county: * * * *Lake Marinuka.*

(u) Waukesha county: Brown's lake in section thirty of township five north, range eighteen east; Eagle lake; *Little Muskego lake; Phantom and Howett's lakes.*

(2) No person shall take, catch or kill fish, or fish for fish of any variety through the ice of any of the inland waters of the state from January first to the succeeding thirtieth day of April of any year except in the following counties: Bayfield, *except in Owen lake*, Calumet, * * * Crawford, Dane, Outagamie, Waupaca, Winnebago and Waushara, *and except the waters of the Mississippi river and the lakes, bays, bayous and sloughs tributary thereto, other than Lower St. Croix and up the St. Croix river to the Dells, and connected therewith in the counties bordering on the Mississippi river, or in the waters of Allouez bay, Superior bay, St. Louis bay, and St. Louis river connected with Lake Superior; Lake Winnebago in Fond du Lac county; Lemonweir river in Juneau county; Lake Wausau and Eau Claire river in Marathon county; Twin lakes and Pike lake in Polk county; the*

Chippewa river from the southern limits of Jim Falls, Wisconsin, to the mouth of said river, including the sloughs and bayous thereof, and Beef slough and Half Moon lake in Eau Claire county; and from January first to the succeeding first day of March in Delavan lake, Geneva lake and Turtle lake in Walworth county and in Pelican lake in Oneida county, and except as otherwise provided in this chapter. In Walworth county the bag limit for cisco shall be forty, but the total catch shall not exceed twelve pounds per day. The bag limit for cisco in Waukesha county shall be twenty-five per day.

SECTION 2. A new paragraph is added to subsection (1) of section 29.28, and a new subsection is added to section 29.28 of the statutes to read: (29.28) (1) (aa) Bayfield county: Owen lake.

(4) Any person may fish through the ice from January first to the succeeding first day of March in all waters of Lincoln county except trout streams, for perch, suckers, red horse, bullheads and sunfish; and for any variety of fish in all waters of Oneida and Forest counties not specified in paragraphs (e) and (1) of subsection (1), and also excluding trout streams, with not to exceed two lines and one hook for each line, with a bag limit of three pike and five pickerel each day.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 278.

AN ACT to amend section 346.39 and to create section 29.64 of the statutes, relating to assault on conservation wardens, and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 346.39 of the statutes is amended to read: 346.39 Any person who shall knowingly resist any sheriff, deputy sheriff, constable, marshal, *conservation warden* or other ministerial officer while engaged in the lawful execution of any civil or criminal process issued by any court, body, board or officer authorized to issue the same, or in lawfully doing any act as such
