CHAPTER 41.

AN ACT to amend subsection (2) of section 74.15 of the statutes, relating to payment of county school taxes.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (2) of section 74.15 of the statutes is amended to read: (74.15) (2) Out of the taxes collected the treasurer shall first pay the state tax to the county treasurer, then the equalization tax levied by the county for school purposes, and shall then set aside all sums of money levied for school taxes, then moneys levied for the payment of judgments, then all sums raised as special taxes in the order in which they are levied, then taxes for the payment of principal and interest on the public debt, then taxes for bridge purposes, then for fire purposes, then for streets and other public improvements, and lastly county taxes. Delinquent returns shall be made to the county treasurer in all respects as required by the statutes, and thereafter such proceedings shall be had with reference to the delinquent taxes so returned as are provided for in case of delinquent returns from towns.

CHAPTER 42.

AN ACT to amend paragraph (e) of subsection (1) of section 102.11 of the statutes, relating to indemnity in the workmen's compensation act for persons under thirty years of age.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Paragraph (e) of subsection (1) of section 102.11 of the statutes is amended to read: (102.11) (1) (e) If an em-

ploye is * * * *under thirty years of age* and is permanently disabled, his weekly earnings on which to compute the indemnity accruing to him for permanent disability shall be determined on the basis of the earnings that such * * * *employe*, if not disabled, probably would earn after attaining the age of * * * *twenty-seven years*. Unless otherwise established his earnings shall be taken as equivalent to the amount upon which maximum weekly indemnity is payable.

CHAPTER 43.

AN ACT to amend subsection (1) of section 29.26 of the statutes, relating to fishing in the Mecan river in Marquette county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Subsection (1) of section 29.26 of the statutes is amended to read: (29.26) (1) No person shall take, capture, or kill fish of any variety, or fish for fish during the close season for trout, in streams and creeks containing trout, except the waters of the Wolf river and creeks and streams flowing into the same between the dam on the Wolf river at the outlet of Post lake in the town of Elcho and the bridge over the Wolf river at Pierson in the town of Ainsworth, all in Langlade county and except that suckers may be speared between March fifteen and May first in the east branch of the White river between Dudley bridge in the town of Dakota and the Marquette county line, in the west branch of the White river between the Sonora bridge in the town of Dakota and the Marquette county line, in the Mecan river between the Zinke bridge in the town of Richford in *Waushara county* and the *Budsin bridge in the town of Crystal lake in Marquette county* * * * , in Willow creek between the point where the two branches of said stream unite in section twelve, township eighteen north, range eleven east, town of Marion and Lake Poygan, in the Pine river between the point where said stream crosses the highway in section three, township nineteen north, range ten east,
