CHAPTER 64.

AN ACT to amend the introductory paragraph to section 29.18 and to create section 29.175 of the statutes, relating to open season for upland birds.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The introductory paragraph to section 29.18 of the statutes is amended to read: (29.18) (Introductory paragraph) A close season is established for each variety of wild animals and birds named herein, extending during all the time in each year except the open season period embraced within the dates, both inclusive, specified for each variety and each locality, respectively, or designated by the conservation commission pursuant to section 29.175; and except as expressly provided in this chapter, no persons shall hunt or trap any such wild animal or bird at any time other than the open season therefor, nor in the open season in excess of the number designated for each variety or each locality, respectively, nor wild birds of more than one variety, except a mixed bag limit of twenty each day in the open season, but containing not more than the bag limit of any one variety. Wild ducks and coots or mud hens shall be deemed, collectively, one variety.

SECTION 2. A new section is added to the statutes to read: 29.175 The conservation commission, upon first making an investigation and finding, is authorized to designate, at any time, an open season for any variety of upland birds, within a designated area when the supply of such birds warrants an open season. The commission shall during such time take added precaution for the protection of all game within such area.

SECTION 3. This act shall take effect upon passage and publication.

CHAPTER 65.

AN ACT to amend section 253.30 of the statutes, relating to the board of county judges.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Section 253.30 of the statutes is amended to read: 253.30 The several county judges of the state shall constitute a board to be known as the "Board of County Judges." They shall hold * * * a meeting * * * each year * * * , at such time and place as they may determine. They shall make such rules and regulations in accordance with law, and not inconsistent with the rules of practice adopted by the supreme court, as they shall deem advisable to promote the administration of the judicial business of the county courts of the state, and transact such other business as may properly come before them. Said board shall elect such officers as they may deem advisable for the proper conduct of their business, and such officers shall be elected for such terms as the board of county judges may determine. Such board may prescribe rules or by-laws for the conduct of their business. Each county judge attending the meeting or meetings of the board shall on presenting his certificates of attendance to the county treasurer of his county be reimbursed for his travel and hotel bills out of the general fund in the county treasury * * * .

SECTION 2. This act shall take effect upon passage and publication.

CHAPTER 66.

AN ACT to repeal the subdivisions designated "ninth" and "tenth" of paragraph (d) of subsection (2) ; and to amend the introductory paragraph of subsection (2) of section 102.09 of the statutes, relating to the waiting period under the workmen's compensation act.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. The subdivisions designated "ninth" and "tenth" of paragraph (d) of subsection (2) of section 102.09 of the statutes are repealed.

SECTION 2. The introductory paragraph of subsection (2) of section 102.09 of the statutes is amended to read: (102.09) (2)
