CHAPTER 528.

AN ACT to create 40.16 (12) of the statutes, relating to powers of school boards to apply for, receive and expend federal school aid moneys.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

40.16 (12) of the statutes is created to read:

40.16 (12) The boards of common school districts, high school districts and city school districts are authorized to apply for, receive and expend moneys made available to them by any act of congress for agricultural, vocational or military training or for enlargement of educational facilities including teaching staff due to activities of the federal government in connection with the present emergency; provided that the acceptance of such money shall not be conditioned upon or result in the expenditure of funds by such districts.

CHAPTER 529.

AN ACT to renumber 17.21 (2) to be 17.21 (2) (a) and to create 17.21 (2) (b) of the statutes, relating to filling vacancies occurring in the office of judge of county court or of any special court created under the general law or by special act with jurisdiction throughout the county, by reason of his induction into the armed forces of the United States while at war.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 17.21 (2) of the statutes is renumbered to be 17.21 (2) (a).

SECTION 2. 17.21 (2) (b) of the statutes is created to read:

17.21 (2) (b) Notwithstanding any provision of the law to the contrary any vacancy occurring in the office of the judge of any county court, or of any municipal, superior, district, civil or other special court created under the general law or by special act and with jurisdiction throughout the county, by reason of the induction of such judge into any branch of the armed forces of

the United States when at war, shall be filled by appointment by the governor of a qualified person who shall continue to act as judge of such court for the residue of the unexpired term or until the judge so inducted shall be discharged from military service and resume his duties and functions as judge of said court, whichever period is the shorter. When the judge so inducted shall be discharged from military service before the expiration of the term for which he was elected or appointed he shall thereupon resume his duties and functions as judge of such court until such expiration. When the compensation of the judge of such court or any part thereof is an annual salary the judge so inducted and person so appointed to fill the vacancy shall each receive as compensation for his services as judge such proportion of such annual salary in any year as the number of months or parts of months he served in such year as judge bears to the number of months in the year; and when the compensation of the judge of such court or any part thereof is on a fee basis the judge so inducted and the person appointed to fill the vacancy shall each receive such fees for his compensation as may accrue during the period which he serves.

CHAPTER 530.

AN ACT constituting an emergency executive budget bill, making emergency additions to certain existing appropriations for the fiscal year 1942-1943.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. There is appropriated from the general fund to the governor for the fiscal year ending June 30, 1943, \$5,000 to supplement the appropriation for the administration of his office made by section 20.02 (1); \$2,000 to supplement the appropriation for contingent expenses made by section 20.02 (2); and none to supplement the appropriation for the state department of research made by section 20.02 (8).

SECTION 2. There is appropriated from the general fund to the Grand Army Home for Veterans for the fiscal year ending
