

arrangement of and spacing between lines indorsed on the fourth page of the policy may be modified by the insurer to suit its convenience. It shall also be optional for the insurer to insert the words "renewal of number" on the first page of the policy followed by a blank line on which an appropriate number may be placed. *In lieu of the signatures on such policy by the president and secretary of an insurer having no such officer or officers in this country, the same may be executed by such other officer or officers as have authority so to do.*

### CHAPTER 252.

AN ACT to amend 16.61 of the statutes, relating to civil service examinations in cities of the first class and compensation of examiners.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

16.61 of the statutes is amended to read:

16.61 \* \* \* **APPOINTMENT OF EXAMINERS: COMPENSATION.** (1) The board shall control all examinations, and may, whenever an examination is to take place, designate a suitable number of persons, either in or not in the official service of the city, to be examiners, and it shall be the duty of such examiners \* \* \* to make return or report thereof to such board \* \* \*. The board may, at any time, substitute any other person, whether or not in such service, in the place of any one so selected; and the board may themselves, at any time, act as such examiners, and without appointing examiners. The examiners, at any examination, shall not all be members of the same political party, and no person shall serve in an examination of candidates for office under the provisions of this act in case of a relative or connection by marriage within the degree of first cousin.

(2) *Persons in the service of the city shall not be compensated for acting as examiners if they are public officers or if their service as examiners is rendered during their paid working schedule. But the board is hereby authorized to compensate*

*employes of a school board or board of vocational education for serving as city service examiners beyond their regular working hours and beyond their regular duties as such employes.*

### CHAPTER 253.

AN ACT to amend 38.08 (4) (n) of the statutes, relating to the powers of school boards in cities of the first class.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

38.08 (4) (n) of the statutes is amended to read:

38.08 (4) (n) From time to time to make arrangements with the school boards or boards of education or other managing bodies of the schools in any city or school district in \* \* \* *the United States or elsewhere* for the exchange of one of its teachers and his services for a teacher of any such other city or school district and his services, for a period not to exceed one school year in any case. Such agreements, among other appropriate provisions, shall provide the manner, and by which board or managing body, the salaries of any such exchange teachers shall be paid, and that any teacher regularly employed by the board under this chapter shall receive credit for such year of outside teaching service in the computation of any benefits to which he may be entitled under the provisions of section 38.24, and the manner in which the monthly reservations payable under said section shall be paid. The board in any city under this chapter shall determine the qualifications and compensation of any such outside teacher who may render services in the schools under its jurisdiction, and such outside teacher so rendering services shall be counted as a regular teacher in such city in the computation of state and county aids payable to such city.
