**CHAPTER 498.**

AN ACT to create 20.57 (8) of the statutes, relating to compensation to relief workers and their dependents, and making an appropriation.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

20.57 (8) of the statutes is created to read:

20.57 (8) COMPENSATION TO RELIEF WORKERS. On the effective date of this subsection, \$2,371.71 as a nonlapsible appropriation, to pay awards issued or to be issued by the industrial commission for benefits to relief workers and their dependents on account of injuries which were sustained by such relief workers in the course of their work under the Wisconsin emergency relief administration plan.

**CHAPTER 499.**

AN ACT to amend 16.31 (1) of the statutes, relating to appointment of members of the Milwaukee county civil service commission.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 16.31 (section heading) is revised to read: MILWAUKEE COUNTY CIVIL SERVICE COMMISSION; APPOINTMENT; TERMS.

SECTION 2. 16.31 (1) of the statutes is amended to read:

16.31 (1) There shall be a civil service commission in every county containing 200,000 inhabitants or more according to the last state or United States census, called "Commission" in sections 16.31 to 16.44 \* \* \*. Such commission shall consist of 5 members, \* \* \* all of whom shall be legal residents of the county. *Appointments shall be made on the basis of recognized and demonstrated interest in and knowledge of the problems of civil service.* No person holding any elective or appointive public

position or office of any sort in said county government shall be appointed thereon.

### CHAPTER 500.

AN ACT authorizing and directing the state department of public welfare to grant to Wisconsin Public Service Corporation a perpetual easement to erect, maintain and operate an electric transmission line over and across the land of the Winnebago state hospital situated in the west one-half ( $W\frac{1}{2}$ ) of section thirty-five (35), township nineteen (19) north, range sixteen (16) east of the fourth principal meridian, Winnebago county.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

The state department of public welfare is authorized and directed to grant to Wisconsin Public Service Corporation, its successors and assigns, on payment of such consideration as the state department of public welfare may fix, a perpetual right, privilege and easement to erect, maintain and operate an electric transmission line, comprising H frame tangent structures, conductors and other wires, anchors, guy wires, braces and other usual appendages and appurtenances of such kind as Wisconsin Public Service Corporation, its successors and assigns may from time to time determine, for transmitting electric current over and across land of the Winnebago state hospital situated in the town of Oshkosh, Winnebago county, Wisconsin described as follows:

The west one-half of the northwest quarter of section 35, township 19 north, range 16 east of the fourth principal meridian.

The center of the transmission line is to be located approximately as follows:

Commencing at a point in the west line of the northwest quarter of said section 35 approximately 500 feet north of the southwest corner thereof and running thence northeast approximately 2,327 feet to a point in the north line of the
