### CHAPTER 516.

AN ACT to repeal 114.136 (6) and to amend 59.97 (6) and 114.12 of the statutes, relating to aeronautics and zoning.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 59.97 (6) of the statutes is amended to read:

59.97 (6) The county board may by ordinance zone *and rezone* any lands owned by the county without necessity of securing the approval of the town boards of the towns wherein such lands are situated and without following the procedure outlined in subsection (2).

SECTION 2. 114.12 of the statutes is amended to read:

114.12 Any lands acquired, owned, controlled or occupied by such counties, cities, villages and towns for the purposes enumerated in section 114.11 hereof shall and are hereby declared to be acquired, owned, controlled and occupied for a public purpose, and as a matter of public necessity, and such cities, villages, towns or counties shall have the right to acquire property for such purpose or purposes under the power of eminent domain as and for a public necessity including property owned by other municipal corporations and political subdivisions and including any street, highway, park, parkway or alley, provided that no state trunk \* \* \* highway shall be so acquired without the prior consent of the state highway commission \* \* \*. Whenever any such street, highway, park, parkway or alley shall be so acquired *and the county, city, village or town as the case may be shall own land on both sides of such street, highway, park, parkway or alley, it may, notwithstanding any other provisions of law, be vacated and closed by resolution of the governing body of the county, city, village or town acquiring it and no damages shall be assessed against such county,*

*city, village or town by reason of such closing, provided that if such closing shall leave any part of such street, highway, parkway or alley without access to another public street or highway, the county, town, city or village effecting such closing shall immediately provide such access at its expense.*

SECTION 3. 114.136 (6) of the statutes is repealed.

#### CHAPTER 517.

AN ACT to renumber 40.16 (14) to be 40.16 (14) (a) and to create 40.16 (14) (b), (c) and (d) and 40.53 (17) of the statutes, relating to health examinations for school employes and school children.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

SECTION 1. 40.16 (14) of the statutes is renumbered 40.16 (14) (a).

SECTION 2. 40.16 (14) (b), (c) and (d) are created to read:  
 40.16 (14) (b) The school district board of districts in counties containing less than 500,000 population, may, as a condition of employment, require periodic health examinations of all school employes. If such examinations are ordered, they shall be required of every school employe of the district except those objecting thereto on religious grounds. No employe shall be discriminated against for raising such objection unless there is reasonable cause to believe that he is infected with a communicable disease. The cost of such examinations, including x-rays, shall be paid out of district funds. The employe may be examined by any licensed physician selected by the employe. Such physician shall make confidential a report of such examination and chest x-rays on a standard form to be prepared by the state board of health to a licensed physician employed by the board of education, who shall make recommendations therefrom to the board and to the employe.

(c) For the purpose of paragraph (b) a "school employe" is defined as anyone employed by the board of education of the school district who comes in contact with children or who handles
