CHAPTER 72.

AN ACT to amend 38.07 (6) of the statutes, relating to public schools in cities of the first class.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

38.07 (6) of the statutes is amended to read:

38.07 (6) The board has power, subject to the powers and regulations of the city service commission, to employ * * * *school engineers and janitorial assistants * * * necessary * * * for the school buildings and grounds of its city* and to fix their compensation * * *. The principal * * * shall be custodian of all * * * *school premises over which he presides and shall have the general supervision * * * thereof. The duties and responsibilities of the principal as custodian of the building and those of the school engineer shall be as fixed by the board.*

CHAPTER 73.

AN ACT to amend 29.147 (1) of the statutes, relating to sportsmen's licenses.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

29.147 (1) of the statutes is amended to read:

29.147 (1) Sportsmen's licenses shall be issued by the state conservation commission or its authorized agents to any resident of this state over the age of 15 years and being a citizen of the United States duly applying therefor and paying a license fee as herein prescribed. The minimum fee for each such sportsmen's license is \$5, but any applicant, at his option, may pay an additional or greater fee therefor. Licenses * * * shall be issued as of * * * August 31 in each year and expire one year from the date of issue. *The expiration date of all sportsmen's licenses of current series issued as of April 30 under the provisions of chapter 196, laws of 1943, is extended*

to August 31 next following the effective date of this amendment (1947).

CHAPTER 74.

AN ACT to amend 233.05 and to create 235.73 of the statutes, relating to purchase money mortgages.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 233.05 of the statutes is amended to read:

233.05 Where a husband * * * purchases land * * * during coverture and * * * as a part of the transaction of purchase executes a purchase money mortgage thereon or a portion thereof to secure the payment of all or a part of the purchase money, his widow shall not be entitled to dower out of such mortgaged land * * * as against the mortgagee or those claiming under him, although she * * * did not * * * unite * * * in such mortgage, but she shall be entitled to * * * dower as against all other persons.

SECTION 2. 235.73 of the statutes is created to read:

235.73 PURCHASE MONEY MORTGAGE DEFINED. A purchase money mortgage is one given as part of the transaction of purchase to the vendor of real estate for all or a part of the purchase money or to a third person who advances all or a part of the purchase money.
