CHAPTER 87.

AN ACT to amend chapter 32, laws of 1921, section 6 (third paragraph), relating to the power of the judge of the county court of Chippewa county to charge a jury when performing the duties of a justice of the peace.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

Chapter 32, laws of 1921, section 6 (third paragraph) is amended to read:

(Chapter 32, Laws of 1921) Section 6 (Third paragraph). The judge of said court shall keep a justice docket, shall have the care and custody of all books, papers and records therein, shall preside at trials, administer oaths, issue process as in other cases, tax the costs, and perform all of the duties required of and imposed upon justices of the peace in such cases, and in addition thereto, may charge the jury.

CHAPTER 88.

AN ACT to amend 111.13 of the statutes, relating to meetings of the advisory committee of the employment relations board.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

111.13 of the statutes is amended to read:

111.13 The board shall appoint an advisory committee consisting of one member of the board who shall represent the general public and who shall act as chairman, and an equal number of representatives of employes and employers. In selecting the representatives of employes, the board shall give representation to organizations representing labor unions both affiliated and nonaffiliated; and in selecting representatives of employers it shall give representation to employers in agricultural, industrial and commercial pursuits. The board may refer to such committee for its study and advice any matter having to do with the relations of employers and employes.

Such committee shall give consideration to the practical operation and application of this subchapter and may make recommendations with respect to amendments of this subchapter and shall report to the proper legislative committee its view on any pending bill relating to this subchapter. *Regular meetings of such committee shall be held on the first Monday of each alternate month following the effective date of this amendment (1947). Special meetings of the committee may be called at other times by the board.* Members of the advisory committee shall receive no salary or compensation for service on said committee, but shall be entitled to reimbursement for necessary expenses.

CHAPTER 89.

AN ACT to amend 41.13 (4) of the statutes, relating to vocational and adult education.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

41.13 (4) of the statutes is amended to read:

41.13 (4) The board shall co-operate with the * * * *United States office of education and the federal government* in the execution of the provisions of the United States vocational education act and any federal statutes pertaining to vocational education and amendatory or supplementary acts thereto, and is hereby empowered with full authority so to co-operate. The state treasurer is hereby designated custodian of all funds allotted to this state from the appropriations made by said act, and he shall receive and provide for the proper custody and disbursement of the same in accordance with said * * * *federal statutes.*
