CHAPTER 96.

AN ACT to create 59.08 (22m) of the statutes, authorizing counties to appropriate money for participation in the state centennial observance within the county.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

59.08 (22m) of the statutes is created to read:

59.08 (22m) Appropriate money to defray the expense of participation by the county in the state centennial celebration or observance within the county.

CHAPTER 97.

AN ACT to repeal 20.43 (8); to amend 158.04 (5) (e), 158.05 (2), 158.09 (6), 158.11 (1) (b), 158.11 (3), 158.12 (2) (b) and (4); and to repeal and recreate 158.06 and 158.10 (4) of the statutes, relating to barbers and providing penalties.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.43 (8) of the statutes is repealed.

SECTION 2. 158.04 (5) (e) of the statutes is amended to read:

158.04 (5) (e) To operate a barber shop in connection with any other business or dwelling unless there is a substantial, dust or odor-proof partition or wall from the floor to the ceiling, separating the barber shop from such other business or dwelling. Access to the barber shop shall be by means of a separate

entrance. Interior doors leading to the barber shop from adjacent rooms shall be securely locked and closed and shall not be used. Plans and specifications for any barber shop hereinafter established, altered or removed to a new location, showing all details as to entrances, partitions, windows, openings, ventilation, vestibules, toilets, water supply, waste connections, sanitary equipment and other details as may be required by the board shall be submitted to * * * the state board * * * of health. No barber shop shall be opened for business or barbering until approval is given by the state board of health. Any person or persons proposing to open a new barber shop in a new location or to change locations or to make alterations shall first make application for an inspection and approval of the premises, containing an exact description and sketch of the proposed location of said barber shop, and file with the barber division of the state board of health on a form prescribed by the board accompanied by the inspection fee of \$10. Nothing herein shall prohibit the sale of tobacco, newspapers or candy in original packages, or shoe shining or manicuring in barber shops.

SECTION 3. 158.05 (2) of the statutes is amended to read:

158.05 (2) The state board of health shall appoint and may remove for cause 3 barbers, who shall constitute the board of examiners in the barber division. Each of said examiners shall have been engaged in the practice of barbering in this state for at least 5 years immediately prior to his appointment. One of the appointed members shall be selected from a list of * * * 5 names recommended by the *Associated Master Barbers of Wisconsin* * * * and one from a list of * * * 5 names recommended by the *Wisconsin* * * * *Barbers' and Beauty Culture Association*. Not more than 2 persons shall be recommended from any one county. Appointments and removals of examiners may be made without reference to the civil service law. Such lists shall be submitted to the board within 20 days after request therefor is made. *Each examiner shall receive \$10 for each day actually engaged in performing his duties, in addition to his actual and necessary expenses incurred therein.*

SECTION 4. 158.06 of the statutes is repealed and recreated to read:

158.06 EXAMINATIONS. (1) The board of examiners shall conduct all examinations of applicants for journeyman barber

licenses, master barber licenses and shop manager licenses not less than 4 times each year at such time and place as the board may determine. Special examinations shall not be held.

(2) Examinations of applicants for journeyman barber licenses and master barber licenses shall include both practical demonstration and a written and oral test and shall embrace the subjects required to be taught in schools or colleges teaching barbering.

(3) In case any applicant for a license under this chapter fails to pass an examination, the applicant shall be entitled to a further examination within 18 months thereafter without the payment of an additional fee. Such subsequent examination shall be only in such subjects in which the applicant failed in the first examination. No fee shall be refunded except for sickness or other good cause appearing to the satisfaction of the board preventing an applicant from attending and completing an examination.

SECTION 5. 158.09 (6) of the statutes is amended to read:

158.09 (6) Each application for an apprentice's license shall be accompanied by a fee of * * * \$5. *If training is not completed within three years, the renewal fee shall be \$2.*

SECTION 6. 158.10 (4) of the statutes is repealed and recreated to read:

158.10 (4) Any barber from out of the state who is at least 20 years of age and of good moral character and temperate habits and has completed the eighth grade as shown by certificate or affidavit, or has an equivalent education as determined by the state board of vocational and adult education, and has an active license or certificate as a practicing barber with 4 years' experience from another state which has substantially the same requirements as this state may be granted a journeyman license upon passing an examination in both practical demonstration and a written and oral test in subjects required to be taught in schools or colleges teaching barbering. The fee for the examination shall be \$10. The application blank and fee must be filed with the state board of health at least 10 days previous to the examination. Permission to work pending an examination shall not be granted.

SECTION 7. 158.11 (1) (b) of the statutes is amended to read:

158.11 (1) (b) Who holds an active journeyman's license and who has practiced barbering averaging at least 40 hours a week for one year under a journeyman barber's license in this state or any other state having substantially the same requirements as this state.

SECTION 8. 158.11 (3) of the statutes is amended to read:

158.11 (3) All master barber's licenses shall expire on June 1 next succeeding issuance and be renewed on application on or before the expiration date at a renewal fee of * * * \$3, except that the renewal fee for barbers who are serving in the armed forces of the United States or who first apply for renewal within 6 months after their discharge from the armed forces as provided in section 14.77 shall be \$2. For the restoration of an expired master barber's license the renewal fee shall be \$5.

SECTION 9. 158.12 (2) (b) and (4) of the statutes are amended to read:

158.12 (2) (b) Who has satisfactorily passed an examination conducted by the board to determine his fitness in managing a shop. The fee for examination of a shop manager's license shall be \$10. The application blank and fee for such examination must be in the office of the state board of health at least 10 days previous to the examination which shall consist of a written examination concerning the barber law, sanitary rules, sanitation and sterilization. This paragraph does not apply to any person holding an unexpired shop manager's license on June 5, 1943.

(4) All shop managers' licenses shall expire on June 1 next succeeding issuance and be renewed on application on or before the expiration date at a renewal fee of \$3. For the restoration of an expired shop manager's license the renewal fee shall be * * * \$5.

SECTION 10. This act shall take effect September 1, 1947, except section 8 which shall take effect upon passage and publication.
