CHAPTER 29, LAWS OF 1967

AN ACT to amend various sections of the statutes to delete surplus words (Revisor's Bill).

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. Wherever the words "is authorized to and shall", "it shall be the duty of", "is empowered and required to", "it shall be the duty of and it shall have power and authority to", or words of similar import are used in the following sections, they are deleted and the word "shall" is inserted in the appropriate place in the sentence: 23.09 (8), 23.10 (2), 23.11 (1), 23.14 (16), 23.25 (2), 23.27 (5) (intro.), 25.14 (4), 26.18, 26.20 (2) and (7), 27.015 (7), 27.065 (2) (b), (5) and (13) (a), 29.05 (9), 34.05 (3), 35.50, 36.03, 36.20 (3), 36.22, 36.225 (4), 38.24 (9) (b) and (15), 43.03 (intro.), 43.05, 43.51 (6), 44.02, 45.17, 45.18, 45.185 (2) and (3) and 45.42 (3).

SECTION 2. Wherever the term "person, firm or corporation", "corporation or individual" or "persons or corporations", is used in the following sections, the word "person" or "persons" is substituted: 23.09 (7) (h), 23.095 (1) and (3), 26.14 (2) and (8) (b), 26.20 (10), 26.21, 27.05 (4), 29.134 (1) (c), (d), (g) and (h), (2), (5) and (7), 29.336 (4), 29.65 (1) (intro.), 36.20 (6) and 36.30 (3).

SECTION 3. Wherever the abbreviation "OASI" or "OASDI" or the words "old-age and survivors insurance" or "old age, survivors and disability insurance" appear in the following sections of the statutes, the abbreviation "OASDHI" is substituted: 20.850 (3) (m), 20.890 (1) (w), 23.14, 38.24, 42.20, 42.241, 42.242, 42.245, 42.246, 42.40, 42.45 and 42.49.

SECTION 4. The phrase "from time to time" is deleted wherever it appears in the following sections: 23.10 (6), 23.26 (7), 24.09 (1), 25.01 (1), 27.04 (1), 28.11 (5) (a), 29.21, 29.51 (1) (f), 35.23, 35.90, 36.04, 36.13 (8), 36.185 (5) (a), 36.34 (1), 37.04, 38.07 (5), 38.08 (4) (h) and (n), 38.09 (3), 38.13 (1), 42.22 (7), 42.50 (1) (intro.), 43.38 (4), 44.04 (1), 44.05 (2), 44.06 (2), 44.12 (1) and (3), 44.13 (1) and 44.14 (1) and (4).

SECTION 5. Wherever the words "in their discretion", "in his discretion" or "in its discretion" are used following the word "may" in the following sections, they are deleted: 24.03, 24.251, 29.49 (1) (b), 29.571 (2); 29.578 (14) (a), 29.595 (2) (b), 29.63 (3) (intro.) and (d), 34.03 (1) (i), 36.185 (5) (d), 37.10 (1), 38.07 (3), 38.08 (4) (k), 42.67 (1) and (2), 43.25 (3), 43.47 (3), 44.02 (7) and 44.12 (3).
