

CHAPTER 169 , Laws of 1981

AN ACT to repeal 25.001 (1); to renumber 25.001 (2) to (6), 25.01 to 25.13 and 25.21 to 25.27; to renumber and amend 25.001 (intro.); to amend chapter 24 (title); and to create subchapter I (title) and subchapter II (title) of chapter 24 of the statutes, relating to renumbering statutes relating to the responsibilities of the board of commissioners of public lands (suggested as remedial legislation by the board of commissioners of public lands).

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

LAW REVISION COMMITTEE PREFATORY NOTE: This bill is a remedial legislation proposal, requested by the board of commissioners of public lands, and introduced by the law revision committee under s. 13.83 (1) (c) 4 of the statutes. After careful consideration of the various provisions of this bill, the law revision committee has determined that this bill makes remedial changes in the statutes, and that these changes are desirable to maintain the accuracy and usefulness of the statutes.

SECTION 1. Chapter 24 (title) of the statutes is amended to read:

CHAPTER 24
PUBLIC LANDS DOMAIN AND THE TRUST FUNDS

SECTION 2. Subchapter I (title) of chapter 24 of the statutes is created to read:

CHAPTER 24
SUBCHAPTER I
PUBLIC LANDS ADMINISTRATION
(precedes 24.01)

SECTION 3. Subchapter II (title) of chapter 24 of the statutes is created to read:

CHAPTER 24
SUBCHAPTER II
TRUST FUNDS
(precedes 24.60)

SECTION 4. 25.001 (intro.) of the statutes is renumbered 24.60 (intro.) and amended to read:

24.60 Definitions. (intro.) ~~As used in ss. 25.01 to 25.13~~ In this subchapter, unless the context indicates otherwise:

SECTION 5. 25.001 (1) of the statutes is repealed.

SECTION 6. 25.001 (2) to (6) of the statutes are renumbered 24.60 (1) to (5).

SECTION 7. 25.01 to 25.13 of the statutes are renumbered 24.61 to 24.75.

SECTION 8. 25.21 to 25.27 of the statutes are renumbered 24.76 to 24.82.

(2) (a) In the list of program responsibilities for the department of justice under section 15.251 (intro.) of the statutes, reference to section "25.12" is deleted and reference to section "24.74" is inserted.

(b) In the list of program responsibilities for the division of trust lands and investments under section 15.251 (4) of the statutes, reference to sections "25.01 to 25.10" is deleted.

(3) In the list of program responsibilities for the department of administration under section 15.101 (intro.) of the statutes, reference to sections "25.06" and "25.08" is deleted and reference to sections "24.67" and "24.70" is inserted.

(4) In the list of program responsibilities for the department of revenue under section 15.431 (intro.) of the statutes, reference to sections "25.06", "25.08", "25.09" and "25.12" is deleted and reference to section "24.74" is inserted.

NOTE: This bill consolidates the program responsibilities of the board of commissioners of public lands into chapter 24 of the statutes.
