1983 Wisconsin Act 496

AN ACT to renumber 450.02 (1) and 450.02 (2) (b); to amend 450.02 (2) (intro.) and (a); and to create 450.02 (2m) of the statutes, relating to registration requirements for pharmacists.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 450.02 (1) of the statutes is renumbered 450.02 (1) (a).

SECTION 2. 450.02 (2) (intro.) and (a) of the statutes are amended to read:

450.02 (2) (intro.) Every ~~such applicant for examination and registration as pharmacist must, in addition, candidate shall~~ submit proof satisfactory to the examining board, ~~of having had at least 48 months of pharmaceutical training consisting of that he or she has:~~

(a) ~~Graduation~~ Graduated from a school or, college of pharmacy or a department of pharmacy of a university, which is recognized approved by the examining board; and which requires for graduation at least a 4-year course. ~~Credit for actual time of attendance at the school, college or department of pharmacy of a university shall be given on the required 48 months of pharmaceutical training. The remainder of the 48 months must be practice and experience in a retail pharmacy or drugstore under the direction and supervision of a registered pharmacist, which practice and experience shall be predominantly work directly related to the selling of drugs, preparing and compounding of pharmaceutical preparations and physicians' prescriptions, and keeping of records and making of reports required under state and federal statutes. The practice and experience shall include an aggregate of 12 calendar months commencing not earlier than the close of the sophomore college year. Credit for periods of practice and experience shall be allowed in the discretion of the director of the university of Wisconsin pharmacy internship program in accordance with rules adopted by the pharmacy internship board. The examining board may upon satisfactory proof recognize and accept evidence of practice and experience performed in whole or in part in any other state provided the same~~

(b) Completed an internship program in the practice of pharmacy under sub. (2m) or attained practical experience in the practice of pharmacy in another state comparable to that included in the internship and which is approved and verified by the ~~pharmacy~~ examining board or equivalent agency of ~~such~~ the other state.

SECTION 3. 450.02 (2) (b) of the statutes is renumbered 450.02 (1) (b).

SECTION 4. 450.02 (2m) of the statutes is created to read:

450.02 (2m) (a) Internships in the practice of pharmacy shall be conducted under the general supervision and according to the procedures and standards of the pharmacy internship board.

(b) Internships shall consist of practical experience in the responsibilities of a pharmacist and shall be under the supervision of a pharmacist approved by the pharmacy internship board.

(c) The director of the pharmacy internship program shall determine when an applicant has completed an internship and shall notify the examining board of all applicants who have completed internships.
