

EXECUTIVE ORDER NO. 24

WHEREAS, Chapter 39, Section 735(5), Laws of 1975 requires the transfer of the Division of Health Policy and Planning to the Department of Health and Social Services, as part of the reorganization of that Department, upon the issuance of an Executive Order by the Governor;

NOW, THEREFORE, I, PATRICK J. LUCEY, Governor of the State of Wisconsin, do hereby order and direct that:


1. Executive Order No. 53 be replaced by this order.
2. The Division of Health Policy and Planning (hereinafter: the Division) be transferred, organizationally intact, from the Department of Administration to the Department of Health and Social Services (hereinafter: the Department).
3. The treatment of Sections 15.101(7), 15.103, 20.505(8), and except as it relates to the creation of 20.505(8)(i) and (8)(n), and 20.923(4)(f) 1 and 3 and (6) (cm) of the Wisconsin Statutes by Chapter 39, Sections 37, 40, 183, 184, 238, 244 and 246, Laws of 1975 shall take effect on January 1, 1976.
4. Beginning January 1, 1976, the administrator of the Division shall be appointed by the Secretary of the Department and serve at his pleasure.
5. Beginning January 1, 1976, the administrator of the Division shall report to the secretary of the Department.
6. The position of assistant administrator of the Division shall be established in the classified service under the provisions of Section 16.11 of the Wisconsin Statutes.
7. On January 1, 1976, all positions and incumbents of the Division shall be transferred or laterally moved to the Department, with such personnel transactions considered as movements to positions within the same employing unit.
8. On January 1, 1976, all property, furniture, supplies, records, equipment or other related articles associated with the Division shall be transferred to the Department.
9. For the purposes of finalizing financial transactions, personnel actions and purchases of the Division which have either been executed or are in process, and for the purposes of conveying Division records, property, etc., an inter-agency agreement shall be executed between the Department of Administration and the Department.

10. Staff services provided by the Division of the Health Policy Council and Medical Education Review Committee, prior to January 1, 1976, shall be transferred with the Division to the Department.
11. Every department, independent agency, and statutory council, and their officers and employees, shall cooperate with the staff of the Department in matters relating to the functions of the Health Policy Council and the Department's health planning and development functions.
