EXECUTIVE ORDER #182

Relating to the Recreation of Non-Statutory Committees

WHEREAS, Section 14.019 (1) of the Wisconsin Statutes authorizes the Governor, by executive order, to create and abolish non-statutory committees to conduct studies and advise the Governor;

WHEREAS, pursuant to Section 14.019 (1) (b) of the Wisconsin Statutes, each committee created by the prior administration shall expire on January 4, 2023, unless a new executive order provides for the committee's continued existence; and

WHEREAS, individuals currently serving on such committees will remain members until they resign or until they are removed or replaced by action of the Governor.

NOW, THEREFORE, I, TONY EVERS, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the Laws of the State, do hereby recreate the following councils and committees, effective January 4, 2023, and require each council and committee to submit to me a final report, as required under Section 14.019 (5) of the Wisconsin Statutes.
